CALL TO ORDER, WELCOME, AND REGISTER OF ATTENDANCE:

Casandra Griffin welcomed everyone and brought the meeting into session.

Approval Of The Minutes For The June 6, 2023 Plan Archdale Commission Meeting

Casandra Griffin called for approval of the minutes. Brooke Johnson approved, and Hannah Davis seconded approval.

Bonnie Place Updates and Streetscape Ideas

Discussed receiving \$180,000 grant for improvements for Aldridge Park. The city is under contract for a property at the intersection of Archdale Road and Trindale Road. The Team Better Block visit was discussed; including one of the recommendations to utilize unused land near Bonnie Place to be used for a walking trail and small park. This would require acquiring this land and asking surrounding businesses for easements. They also recommended organizing Bonnie Place so that food trucks can park there and be used. Casandra Griffin recommended making Bonnie Place a one-way road. Dara Matthews had an idea to ask Pinnacle Bank if their parking lot can be used at night for food truck events to make walking to the food trucks safer. Zeb requested that the members pay attention to the side of the road along N. Main Street and let him know if there is a good location for a sidewalk without telephone poles or fire hydrants that would obstruct it.

Additional Items

Discussed changing meeting times to every other month. Members agreed this would be appropriate. Zeb reminded the committee members that they are invited to a tour of Archdale that will explain current progress on Wednesday, August 9. Casandra requested a map of all of the land that the City of Archdale owns, and Zeb stated that he could acquire this for the committee.
