## CHAPTER 1: COMMUNITY OVERVIEW

Creekside Park was created in 1979, thanks to a gift from Bill and Elizabeth Aldridge. Over the past 20 years, the City has invested significant resources into Creekside Park, broadening the options and acreage at the park through strategic land purchases and donations, re-investment of department revenues, and investment of general funds, which has leveraged Parks and Recreation Trust Fund (PARTF) support for continued park development. The park land now covers more than 100 acres and is a destination for residents in Archdale and surrounding communities in northwest Randolph County.

The City of Archdale Parks and Recreation Master Plan from 1992 resulted in a concept plan for major improvements to Creekside Park, including the Recreation Center, which was constructed in 1996. The City of Archdale Parks and Recreation Department last completed a Comprehensive Parks and Recreation Master Plan in 2005. Creekside Park offers a recreation center & gym, disc golf, diamond fields, paved trails, shelters and other facilities. Muddy Creek runs through the park and the site has the remains of an old mill, with the original rock foundation creating a unique natural setting at the Park.

The Needs Assessment was the first phase of the Comprehensive Planning process. The needs assessment provides a thorough analysis of existing facilities, while gathering input on community needs and values as it relates to parks and recreation in the City of Archdale. Surveys, focus groups and parks and recreation advisory board meetings were utilized to develop this plan. Balanced with the conditions and opportunities of the existing facilities audit, public input and desires helped inform the comprehensive plan, which aims to identify and prioritize specific facilities and their potential locations within existing and future park property.

**Community Overview** – Previous recreation plans, population & growth and a comparison of the Archdale Recreation Expenditures compared to peer Cities;

**Public Involvement** – Detailed information on survey responses, focus group feedback, Parks and Recreation Board & staff vision, goals and objectives;

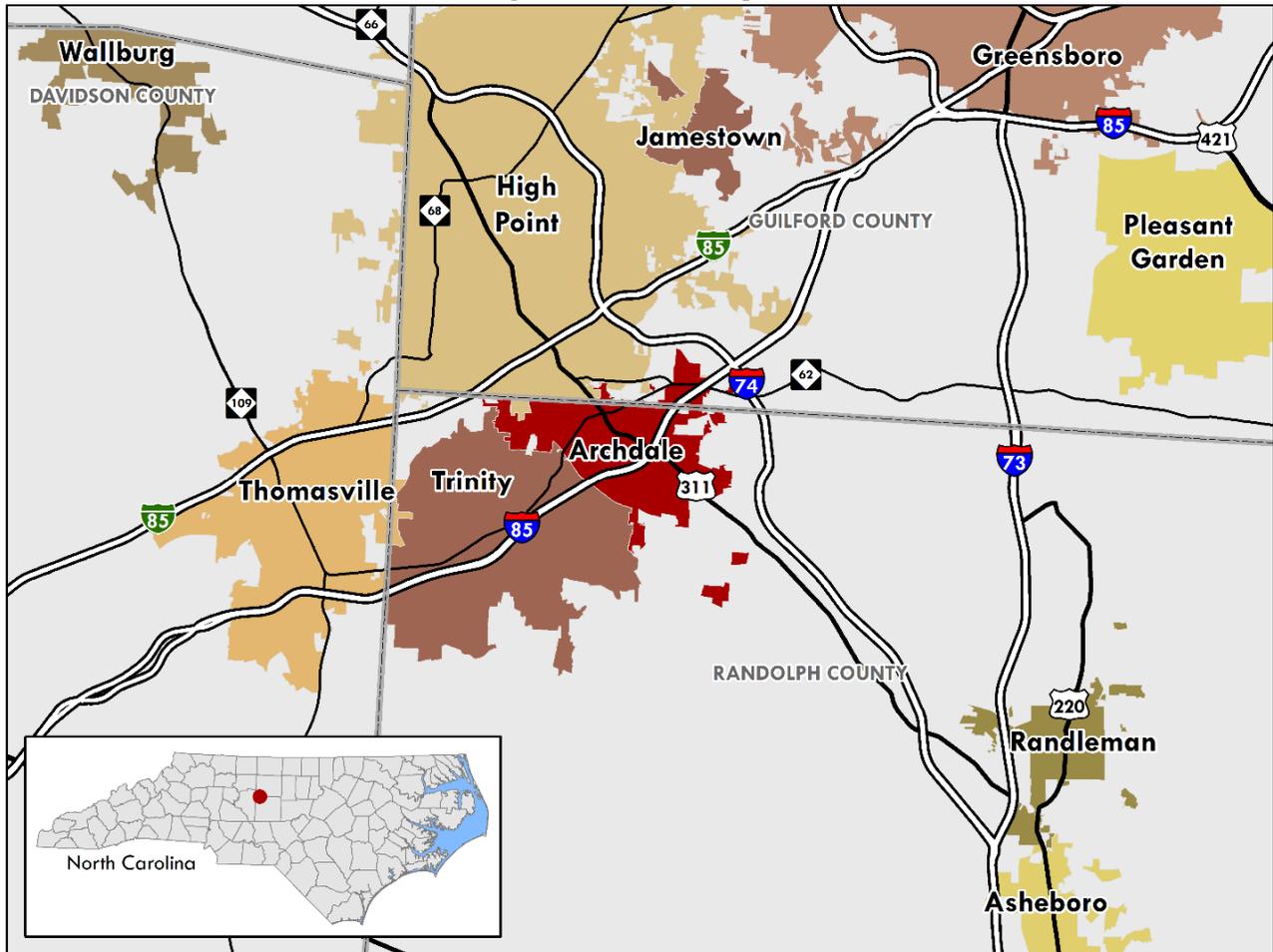
**Existing Conditions and Standards** – Summary of recreation opportunities, standards (e.g. park sizes, facility dimensions), detailed parks and recreation audit and condition review for all City owned parks and recreation facilities; opportunities for repair and renovation are also documented here;

**Parks and Recreation Comprehensive Plan** – Staff, board and facility needs, with a schedule for implementation, cost estimates and proposed facilities map; GIS analysis of potential future parkland based on community standards, environmental constraints and geographic equity.

## Location

Archdale is crisscrossed by the I-85 and US-311 business corridors in northwest Randolph County. The northern part of the City extends into Guilford County. The City is adjacent to Trinity in the southwest and High Point to the north. Currently, Archdale has a population of 11,954 (2015 NCOSBM), is 8.3 square miles in size and has a population density of 1,440 people per square mile.

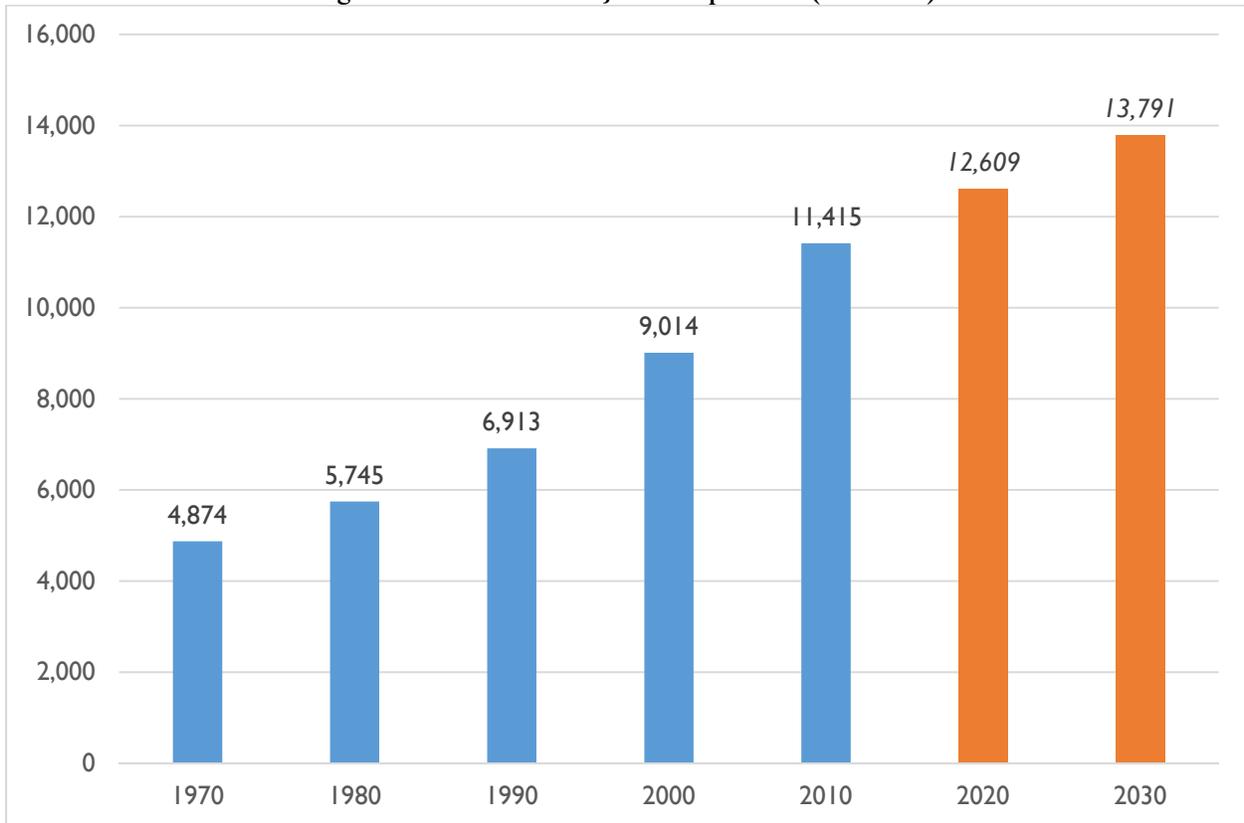
Figure 1: Overview Map



## Population & Growth

In 2015, the certified population estimate for the City of Archdale was 11,954, a slight increase from the 2010 decennial population of 11,415. Since the 1970s, Archdale saw the highest amount of growth in the 1990's with an average growth increase of 3% annually. The population growth has since slowed down with an annual increase of approximately 1% each year between 2010 and 2014. Municipal level population projections were estimated by applying the 1% annual growth each year until 2020, and reducing the annual growth rate to 0.9% until 2030.

## CHAPTER 2: PUBLIC INVOLVEMENT

Multiple strategies to gather public feedback and input into parks and recreation needs, habits and desires were utilized. The parks and recreation advisory board was instrumental in providing important feedback throughout the process. Surveys, focus groups and public input design workshops were also used. Parks and Recreation staff were instrumental in helping to gather public input, provide feedback and assist with plan elements.

### Open House and Design Workshop Summaries

Public meetings were held in November 2015, June 2016 and August 2016. Each workshop had a slightly different format, but did not require attending the entire meeting time to provide feedback. Full meeting survey tools, comment forms and other information is available in the appendices.

November 15, 2015: Open house format meeting with overview maps of park facilities, city-wide map, location map and facility photo simulation summary. Participants: 11

A full copy of the Parks and Recreation Needs Assessment draft was provided to participants. Each participant was provided the opportunity to fill out a comment form and mark on the map where facilities might go, what should be improved or expanded. Moving the basketball court and potential reuse of the upper baseball field were talked about often among attendees. This feedback helped guide development of recommended facilities as best practices and costs were researched and studied.

June 1, 2016: Design workshop using Monopoly budget. Participants: 16

Each participant could purchase facilities with their Monopoly “income” of \$100. Attendees could combine their money to purchase more expensive facilities such as a swimming pool. However not enough people “pooled” their money for a pool. The results from this meeting shows the following facilities were “purchased” (in no particular order): 1. Dog Park, 2. Volleyball Court, 3. Amphitheater, 4. Multi-purpose fields, 5. Challenge

August 31, 2016: Open house format with maps of proposed facilities in Creekside Park and downtown area. Participants: 23

Staff provided the results of proposed facilities “purchased” at the June 1, 2016 workshop, participants were shown a draft site plan for Creekside Park and a conceptual layout of a central neighborhood park. Participants were able to comment on the draft report and also provide feedback through a visual preference survey of facilities proposed for the Archdale Parks and Recreation Department including the challenge course, playgrounds, pump tracks, amphitheater and dog park. The visual preference survey results will be used to better inform the City of Archdale on the design features of key top priority facilities. The visual preference survey was also available following the meeting on the City of Archdale’s Facebook page. The full results of the visual preference survey are included in Appendix D: Meeting Information.

## Parks and Recreation Survey

The Parks and Recreation Survey was distributed between late June 2015 and July 24, 2015. There were 297 households who began the survey, with 74% of respondents living in Archdale. Approximately 260 households - representing 868 people - completed survey questions from all 5 sections of the survey. The surveys were distributed via the following methods:

- Parks and Recreation Department’s e-mail newsletter;
- City of Archdale Parks and Recreation web page link;
- Inserted into the City’s water bill;
- An article was published in the Archdale – Trinity News in late June 2015; and
- Distributed at special events and key civic locations (e.g. 4<sup>th</sup> of July Festival, City Hall, Library and Recreation Center).

The City of Archdale Parks and Recreation Department is conducting a survey to find out how people feel about the City's parks and recreation system, and hear ideas for enhancing the recreational opportunities available in Archdale. To incentivize responses, two gift cards and a gift basket were offered to individuals who completed the survey before July 24, 2015. These prizes were distributed to three randomly selected survey respondents in mid-August 2015. The following is a summary of the survey results. The full results with tables and graphs can be found in the Appendix.

### Section I: Archdale Parks Use

- Creekside Trails and Other Facilities (e.g. picnic shelters, disc golf) are most often used; and
- Nearly half of respondents (47.5%) use the Creekside Trails daily or weekly. (n=295)

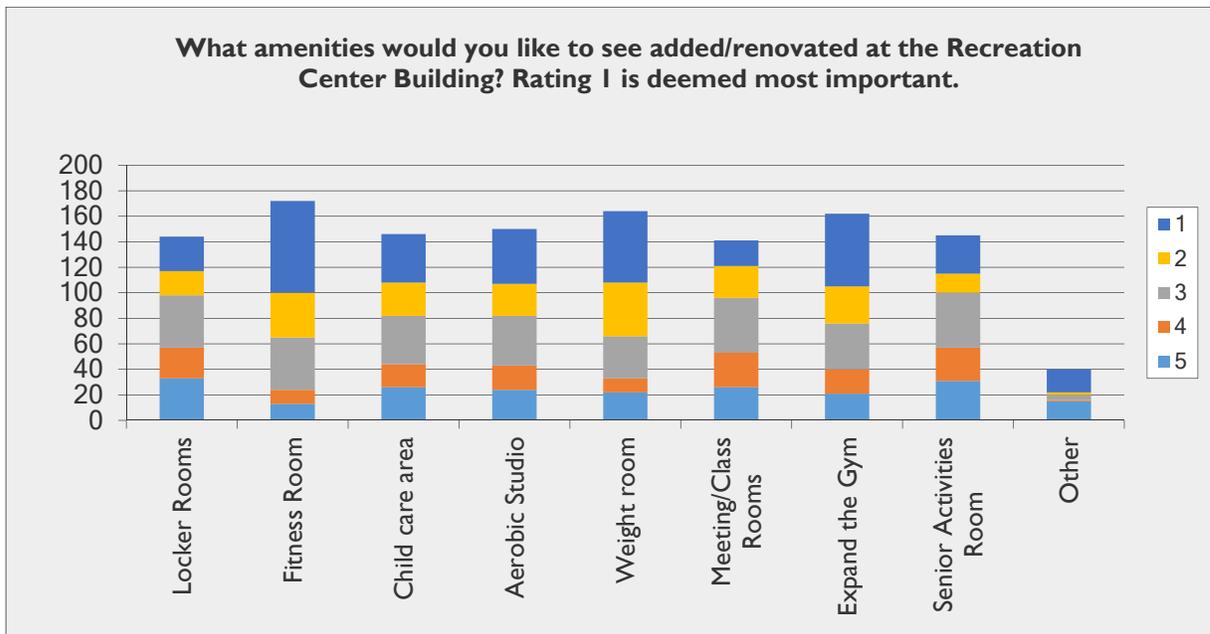
### Section II: How Do You Recreate?

- Cornhole (68.9%), Yard Games (52.0%) and Miniature Golf (43.9%) are the top reported “Games & Activities”; (n=196)
- Concerts (67.0%), Library Events (49.1%) & Art/Craft Shows (49.1%) are the top reported “Arts”; (n=212)
- Swimming (60.3%), Youth Base/Softball (34.7%) and Bowling (33.7%) are the top reported “Athletics”; (n=199)
- Walking (85.6%), Gardening (59.4%) and Playgrounds (55.7%) are the top reported “Passive Outdoor Pursuits”; (n=271)
- Walking (86.3%), Hiking Trails (51.5%) and Fishing (49.6%) are the top reported “Active Outdoor Pursuits”; (n=270)
- Arts & Crafts (47.0%), Aerobics/Pilates/Yoga (39.9%) and Dance (36.1%) are the top reported “Instructional Classes” taken; (n=183)

- Open Gym Time (50%), Adult Programs (41.5%) and Group Exercise Classes (38.7%) are the top reported “Recreation Center Programs” taken; (n=142)
- Fitness Activities (general) (41.3%), Weight Lifting (37.4%) and Zumba (36.9%) are top reported “Fitness Activities”; (n=179) and
- 4<sup>th</sup> of July Festival (76.8%), Farmer’s Market (64%) and Creekside Christmas (49.4%) are the top reported “Special Events” in which people participate. (n=267)

**Section III: What Do We Need?**

- Seasonal Special Events (53.4%), Arts & Crafts (47.9%) and Personal Fitness Classes (37.6%) are the top reported “Parks and Recreation Programs to be added”; (n=234)
- Add a Fitness Room (72), Expand the Gym (57), and Add a Weight Room (56) were ranked as the most important “Amenities to be added/renovated at the Recreation Center Building”; (n=216)



- Add a Municipal Pool with a Splash Pad (159), Expand the Trails at Creekside Park (110) and Add an Amphitheater at Creekside Park (110) were reported as the most important “Facilities to add to the Parks System”; (n=267)
- Music/Concerts (170), Farmer’s Market (167) and Fall Festival (147) were reported as the most important “Types of Special Events people would attend at Creekside Park”; (n=265)
- Elementary (89), Pre-School (66) and Families (62) are the top reported aged groups that are “Adequately served”; (n=237)
- When asked about “expanded revenue options” to help fund parks and recreation expansions and renovations; 45.5% agree; 44.7% are undecided and 9.7% disagree; (n=257)
- No Change (73), Bond Referendum (63) and Annual Household Fee \$25-\$50 (57) are the top reported methods to “support renovation/expansion”; (n=234)

**Section IV: Walking and Bicycling Preferences**

- Walking or Hiking (216) and Multi-Use Trails (87) are the top reported “important trail uses”; (n=254)
- Connects to existing trails (185), Addresses safety concerns (167) and Connects to existing parks (129) are the most “important factors for determining locations of new trails; (n=248)

**Section V: About You...**

- According to self-reported household size, there were 868 persons represented by the 264 respondents to the question about people by age group; age 35-44 (160) represents the most number of respondents; (n=264)
- Archdale residents represented nearly 74% of those who responded to the survey; (n=260)
- Nearly 72% of respondents have lived in Archdale more than 10 years or are a life-long resident; (n=261)
- Household Income of \$75,000-\$100,000 was the most common response at 24.7% of the total response count, while <\$25,000 had the lowest response count with 14 or 6.1% of the responses; (n=231)
- Whites were 94.6% of all respondents; Black or African-Americans were 2.3% of all respondents; (n=259) and
- E-mail (54.6%), Social media (15.8%) and Newspaper (12.3%) are the “best way to notify” respondents of programs and activities.

**Focus Groups**

A total of 3 focus groups for the City of Archdale Parks and Recreation Comprehensive Plan were conducted in August 2015. The attendees consisted of citizens, current or past coaches, regular park users and current staff. The meetings were conducted at different times to accommodate work schedules. One focus group consisted entirely of parks and recreation full and part time staff, the others were a mix of citizens and those directly involved with parks and recreation. Full focus group results for each of the 3 focus groups are included in the Appendix, a summary of common themes are included below and word clouds show common terms in larger print.

## Staff Vision, Goals and Objectives

The Archdale Parks and Recreation Department realized a need for a focused direction when it comes to growth and marketing. There is a mission statement for the Department, but additional direction is needed to achieve the mission. Through staff collaboration an internal vision, with goals and objectives was developed to help the Recreation Department serve the community and determine how to best market amenities.

### **Archdale Parks and Recreational Organizational Goals and Objectives**

#### **Goal A: Provide a safe and accessible park facility for all citizens.**

Objectives:

1. Promote connectivity of parks and trails from existing neighborhoods and high density areas;
2. Park facilities should have good proximity to neighborhoods, transportation, park and/or connector trails, and other parks;
3. Fees and other facility cost should not be so high as to exclude any socioeconomic group;
4. Expand park trails to provide opportunities for active transportation;
5. Moving forward, all park facilities should conform to the requirements of the Americans with Disabilities Act;
6. Decrease employee injuries and increase/insure patron safety at APRD facilities;
7. Ensure staff is trained in and remains current with CPR and First Aid certification;
8. Coordinate and plan events with Community Resource Officer;
9. Ensure ample staff to work programs/events;
10. Produce, provide, and enforce policies and rules; and
11. Maintain current facilities.

#### **Goal B: Provide diverse recreational opportunities.**

Objectives:

1. Recreation activities should be responsive to the needs of different age groups, cultural backgrounds, physical abilities and economic strata;
2. There should be a variety of park types and functions that would include active, passive, cultural, historic, educational or environmental elements;
3. Provide a full range of programs and activities to address community needs and desires; and
4. Implement findings from the Master Plan study.

#### **Goal C: Employ an ongoing system of organization evaluation.**

Objectives:

1. Conduct periodic community surveys and studies;
2. Conduct a departmental self-assessment on a regular basis;
3. Increase efficiency through high tech registration, reservation, and payment software; and
4. Ensure that all departmental goals are being met.

#### **Goal D: Maintain fiscal responsibility throughout the department.**

Objectives:

1. Continue to enforce rules and regulations regarding monetary transactions;
2. Make payments easier by accepting credit cards and consider providing an ATM;

3. Increase awareness, participation numbers, and programs offered to influence revenues in a positive manner;
4. Remove programs with less than desirable participation levels; and
5. Increase sponsorship and partnership opportunities.

**Goal E: Foster collaboration, coordination, and partnerships throughout the community.**

Objectives:

1. Continue to foster relationships with other city, state and federal entities; other city departments; non-profit organizations; boards, commissions and neighborhood groups;
2. Partner with educational institutions for training, education, and intern opportunities;
3. Promote community events and activities that support parks and programs; and
4. Become active members of local organizations.

**Goal F: Increase awareness and usage of Archdale Parks.**

Objectives:

1. Grow marketing coverage;
2. Increase social media presence;
3. Continue to utilize local media to disperse information;
4. Improve website so it is easier to find the information you are searching for;
5. Continue to build email list;
6. Promote the park and local events, through community engagement, and through business partnership; and
7. Offer new and exciting programs for the community.

## CHAPTER 3: EXISTING CONDITIONS AND STANDARDS

The existing conditions and standards chapter compiles a snapshot of where the Archdale parks and recreation system is today. Detailed maps as well as suggested standards for park acreage and types are provided in the following sections: 1) summary of existing recreation opportunities; 2) suggested recreation standards, 3) comparison of recreation expenditures, 3) summary of how the City of Archdale may address recreation standards, needs and community desires, 4) field audit of existing recreation sites operated by the City of Archdale and 5) maps of existing conditions at Creekside Park and Sterling Ridge Park.

### Summary of Existing Recreation Opportunities

The City of Archdale currently operates two park sites. Creekside Park is a 'community park' with over 100 acres serving residents and others that live outside the City of Archdale. Sterling Ridge is a mini-park of about ½ acre in a corner of the neighborhood off Aldridge Road. The facilities assessment provides more detail on City of Archdale owned facilities. There are several other opportunities for recreational activity offered by the City of High Point, the Grubb Family YMCA and four local schools: Archdale Elementary, Trindale School and Archdale-Trinity Middle School in the City and John Lawrence Elementary just outside the City limits on the north side of Archdale.

#### Grubb Family YMCA

The Grubb Family YMCA is affiliated with the High Point YMCA and is located at 609 Trindale Road in Archdale. The YMCA, through paid membership and fees offers the following:

*Classes:* Senior and adult fitness classes; Zumba, indoor cycling (spin), personal training, wellness and nutrition.

*Sports:* adult soccer, volleyball, softball and basketball, youth baseball, basketball, soccer, softball and volleyball.

*Facilities:* Weight and fitness room, splash pad and indoor pool (under construction).

*Other Programs:* After school club and summer camp.

## High Point Parks and Recreation Facilities

The City of High Point operates an extensive network of parks and recreation facilities. The parks and facilities that are located on the southern side of High Point also serve the needs of the Archdale community. For example, the Allen Jay Recreation Center provides a gymnasium, large and small multi-purpose rooms and a kitchen. Adjacent to the

recreation center there are three baseball/softball fields, an outdoor basketball court, picnic shelter, two tennis courts and walking trails that connect the 3 fields.

## Archdale Community Schools

Archdale Elementary School, Archdale-Trinity Middle School, and Trindale Elementary School all have existing playgrounds, outdoor athletic and indoor multi-purpose facilities. The Randolph County Schools policy (Code: 5030 Community Use Facilities) outlines the process for using school facilities. Each school requires large groups (e.g. sports clubs) to fill out a request form for use of the facilities. There is also an option to lease the facilities up to a year or more pending the approval of the County Schools superintendent.

**Archdale Elementary School** provides the following facilities for community use: gymnasium, outdoor walking track, playground area, and a medium sized multi-use paved court. The entire campus is used for the Bush Hill Festival with the gymnasium serving as the emergency shelter during the event.

**Archdale-Trinity Middle School** provides the following facilities for community use: paved track, outdoor basketball courts, open field, a baseball/softball field, and a lined football field.

**Trindale Elementary School** provides the following facilities for community use: gymnasium, auditorium, outdoor track and field facilities, and cafeteria.

## Recreation Standards

Planning for recreation facilities and parks is part science and part art. The process seeks to strike a balance between community values, recreation demands and available resources. The outcome of the planning process is a series of policy, program and facility recommendations to carry the Parks and Recreation department forward with clear direction for the next ten years.

To that end, this section provides analysis and information to aid in forming appropriate standards for City facilities and programs.

### *Local Recreation Facility Standards:*

- Express the accepted minimum standards for recreation facilities across a broad spectrum of communities.
- Provide a guide for determining land requirements for different types of facilities.
- Serve as the foundation for a systems approach to community park planning.
- Act as a clear assessment tool for measuring plan implementation.

In developing facility standards, recreation policy-makers must address two questions: Do these standards reflect our goals and objectives related to recreation and are the standards realistic and attainable within the 2030 planning horizon?

In this section, we explore a variety of methods for developing facility standards, provide standardized descriptions of different types of park sites and identify the minimum requirements for specific types of improvements.

### **Design Criteria**

What makes a good park site? That is often dependent on the recreation goals the site must meet, its geographic location within the community or a unique site feature.

Good park design considers the balance of open play space, buffers and natural areas in relationship to the developed areas of the park site. Topography, streams and other natural land features also influence the ultimate design and flow of a park.

The facilities found or planned for at any given park site are often dependent upon the space available, terrain and a desired park concept. To adequately consider the potential for enhancing existing facilities or development of a new park site, dimension and area requirements for each type of facility are needed.

**Methodology**

Shown here are three methods of calculating the standard or metric for determining existing and future demand for parks and recreation sites. The standards for parks and recreation facilities are

based on national averages from the National Parks and Recreation Association (NRPA) 2016 Field Report. Although the NRPA suggests standards or metrics for the number of facilities, types of facilities and acreage; policy guidance also recognizes that park facilities, needs and demands will vary by community and region.

### AREA PERCENTAGE METHOD

This method of determining recreation demand assumes that a minimum percentage of the total land mass within the City should be reserved for park sites. While simplistic, it gives a gross assessment of the recreation acreage needed within the City. For example, if 1% is the accepted standard for the City of Archdale, with a total size of 8.3 square miles, this would result in the recommended reservation of approximately 53 acres for parks and natural areas. A goal of 5% would reserve approximately 265 acres of park and natural area by 2030, more than doubling the existing park acreage of approximately 100 acres.

### POPULATION RATIO METHOD

This method of determining the desired minimum number of facilities is grounded in the average demand derived from national recreation use surveys. For example, the NRPA Field Report shows that the average parks and recreation agency has 9.5 acres of parks and open space area per 1,000 residents. Based on a projected 2030 population of 13,791, the City would need to add about 30 acres to existing park property to reach the population ratio method goal of 131 acres.

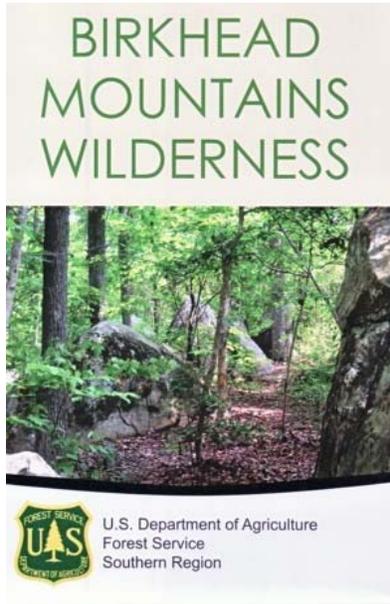
### DENSITY OF PARKS

The ‘density of parks’ standard shows how many parks exist per resident. This metric does not take into account the size and makeup of existing parks, but is based on a 2016 national average of one (1) park for every 2,277 residents. Including school playgrounds at Archdale Elementary, Trindale and Archdale-Trinity Middle school as well as Sterling Ridge and Creekside Park, there are 2,758 residents. Excluding the school locations, there are 6,896 residents per park.



## Typical Park Site Categories

Adopting standard definitions of different types of parks provides a continuity of understanding for staff, elected officials and the public, particularly when new park sites are being sought or planned. These definitions create distinctions between park types, sizes and typical facilities.



*Regional Park.* A park site of 500-1,000 acres or larger which serves multiple communities. A regional park provides opportunities for a wide range of both active and passive outdoor leisure activities on a single site. Generally, 80% of the site is reserved for natural areas and passive activities, and 20% is used for improvements for active outdoor recreation. Regional parks are generally acquired and maintained by the state or a county. Birkhead Wilderness or the Uwharrie National Forest active use areas are example facilities that serve the Regional Park purpose.

*District Park.* A park site of 100-500 acres in size, serving populations within a ten mile radius. While providing a wide range of both active and passive outdoor leisure activities, a district park may often provide indoor recreation venues as well. These parks are generally located in large municipalities or maintained by a county.

*Community Park.* A park site of 20-100 acres in size, serving a single community or neighborhoods within a five mile radius. Focused primarily on active leisure activities, community parks often provide a mixture of indoor and outdoor facilities in a natural setting with ample open space for unstructured play. Creekside Park is an example of a community park.

*Neighborhood Park.* A park site of 5-10 acres in size, serving populations within walking or bicycling distance. Facilities can vary greatly, and may include both passive and active leisure facilities based on community needs and desires.

*Pocket Park.* A park site of one acre or less in size, generally providing areas of greenspace and limited outdoor recreation facilities in highly urbanized areas, intended to serve populations within walking distance. Sterling Ridge Park is an example of a neighborhood park with only about 1/2 acre.

*Specialty Park.* A park site of varying size, located to capitalize on a unique natural, historic or cultural feature. Facilities may vary widely based on need. Sites should be of sufficient size to protect and interpret the particular resource being featured, while allowing maximum use by the public.

*School Park.* Active recreation facilities located on school property, but used and maintained jointly by the school system and a parks and recreation department.

*Greenway or Multi-Use Path.* A linear style park that provides shared greenspace and natural resource management areas, typically located along rivers, creeks or streams in a community. These parks are often enhanced with trails for hiking, bicycling or equestrians where feasible.

*Open Space.* Sites intended to remain in an undeveloped state, generally to provide relief from urban development, preserve natural habitats or maintain the integrity of important natural watershed and drainage systems.

### Recreation Expenditures of Peer Communities

As shown in Table 3, Archdale had a Total (operation + capital expenditures) of \$54.44 per capita parks and recreation expenditures in FY 2014 which is in the lowest among comparison cities. Only Southern Pines has a lower operating expenditure per capita than Archdale.

When averaged over a 5 year time frame, Archdale’s total per capita expenditures are \$87.26, but remain in the lower half of the cohort’s average per capita expenditures over the same time period.

## Summary

Based on the existing inventory of parks and recreational facilities combined with public input received during the master plan process, there will be a need for establishing new park land and facilities. The following improvements in the coming years would help to fulfill recreation and park needs in the City of Archdale.

- 1) Provide more neighborhood & pocket parks;
- 2) Provide a downtown park to serve the central area of Archdale and support a community center that is walkable to neighborhoods and businesses; and
- 3) Fund improvements to Creekside Park to fully utilize prior parkland acquisition including: playground upgrades to increase accessibility, challenge course, picnic shelters, multi-use and natural trail improvements, and multi-purpose field expansion and other projects.

## Future Park Needs Summary

A reasonable goal for Archdale's parks and open space land is 9.5 acres per 1,000 residents. The future park property goal for the City of Archdale would be 131 acres based on the estimated population of approximately 13,791 in 2030. Acquisition of three (3) or four (4) sites for neighborhood parks (10 acres or less) would result in increasing the existing inventory of parks and open space acreage to that goal by 2030.

A focused approach to recreation, greenway and open space dedication as development occurs would insure that smaller park sites would be available to address recreation needs in growth areas. The City is able to acquire parkland through the land development process for future park and open space needs. Land acquisition strategies to locate and secure large Neighborhood Park sites in already developed areas should be pursued to meet recreation needs of the existing community in collaboration with other recreation partners in Randolph and Guilford counties as well as neighboring jurisdictions.

## Facilities Assessment and Audit

The facilities assessment and audit was conducted jointly by PTRC and local recreation staff in September 2015. Creekside Park, the Recreation Center and Sterling Ridge Park were reviewed. Characteristic ratings and conditions of each park facility was completed in the following areas (if applicable):

<b>Natural Areas</b>	This category includes open play fields and undeveloped areas within the park boundaries.
<b>Leisure Facilities</b>	This category includes facilities such as picnic shelters, playgrounds and other non-competitive, man-made features.
<b>Recreation Facilities</b>	This category includes facilities such as ball fields, courts and other active facilities.
<b>Access &amp; Parking</b>	This category includes pedestrian, bicycle and vehicular linkages to and through the site, and supporting parking facilities.
<b>Comfort &amp; Amenities</b>	This category includes tangible elements including restrooms, staff offices, maintenance facilities and other support services located within the park site and intangible elements including general patterns of use, visual quality and overall experience.
<b>Opportunities</b>	This category includes the consideration and identification of recreation improvements at each site.

Facility conditions were rated on a scale of 1-5, with 1 being highest and 5 being lowest.

### Summary

The facilities that Archdale Parks and Recreation maintains appear to be in good condition, however the age of the Recreation Center and the playgrounds at both Creekside and Sterling Ridge are in need of updating and have reached their useful life expectancy. In addition, at Creekside Park the picnic shelter area is in need of new ground cover and the small shelter should be replaced or repaired, as it is structurally unsound. The walking trails, disc golf course and natural areas of the park are very popular and provide a unique park experience.

The following page provides an average of the characteristic ratings by area. Additionally, summary pages with existing conditions, pictures and opportunities are provided below and organized into three sections Creekside Park, Recreation Center and Sterling Ridge Park.

### Audit Rating Summary

Facility conditions were rated on a scale of 1-5, with 1 being best and 5 being worst. Shown below are the average ratings for the 8-12 statements about condition or quality of particular features in each category across the top of table 8.

### Creekside Park Overview

**Description:** Creekside Park consists of over 100 acres of developed land on 16 different parcels of land, with rolling topography and a creek running along the northwest side and heart of the Creekside Park complex. The park is accessed off of S. Main Street and is about 1 mile south from the Interstate 85 exit for S. Main Street. In close proximity to the park are adjacent residential neighborhoods, Randolph Community College, Archdale Public Library, Senior Center, Fire Station and businesses.

**Facilities:** 3 miles of multi-use trails, 3 lighted ball fields, 4 lighted tennis courts, Recreation Center (see Recreation Center summary below), 18-hole disc golf course, 2 playgrounds, 3 T-ball fields, 2 picnic shelters, 1 gazebo, 3 outdoor bathrooms, storage area, seasonal concession stand and open play areas. (see map on the following page)

**Ratings Average:** Facility conditions were rated on a scale of 1-5, with 1 being highest and 5 being lowest.

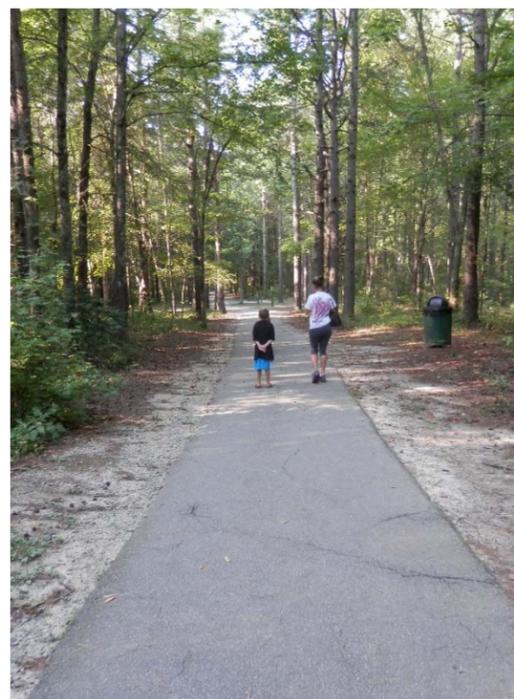

- Acquire more land for future park expansion.

#### Community Partnership Opportunities

- Partnership with the Senior Center for improvements;
- Continue coordination with other recreation partners such as the YMCA, High Point Parks & Recreation and others; and
- Look at partnering with local businesses in Archdale on projects (e.g. Walmart, Sheetz, Bojangles, Lowes, Food Lion, Pioneer, Hafele)

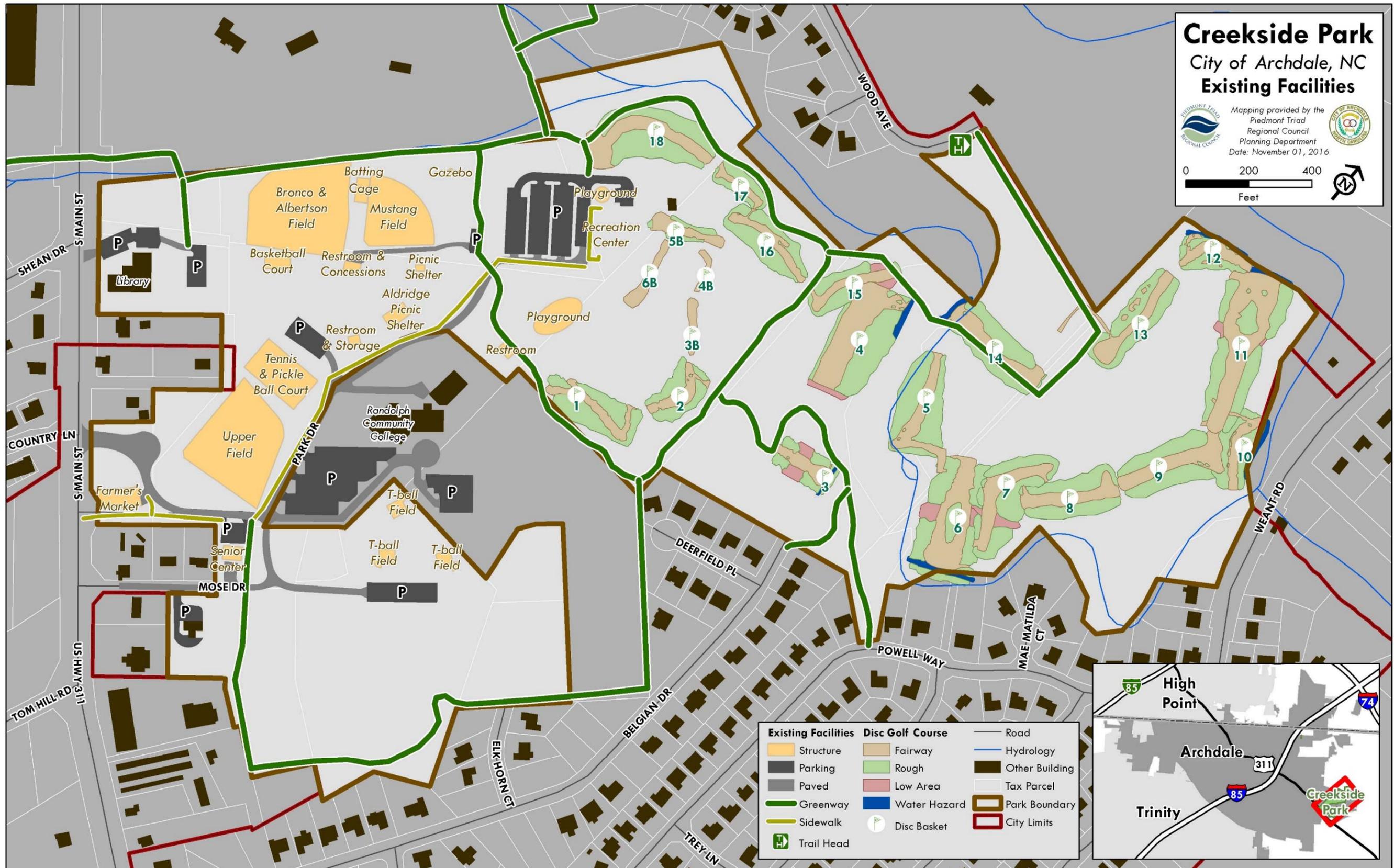

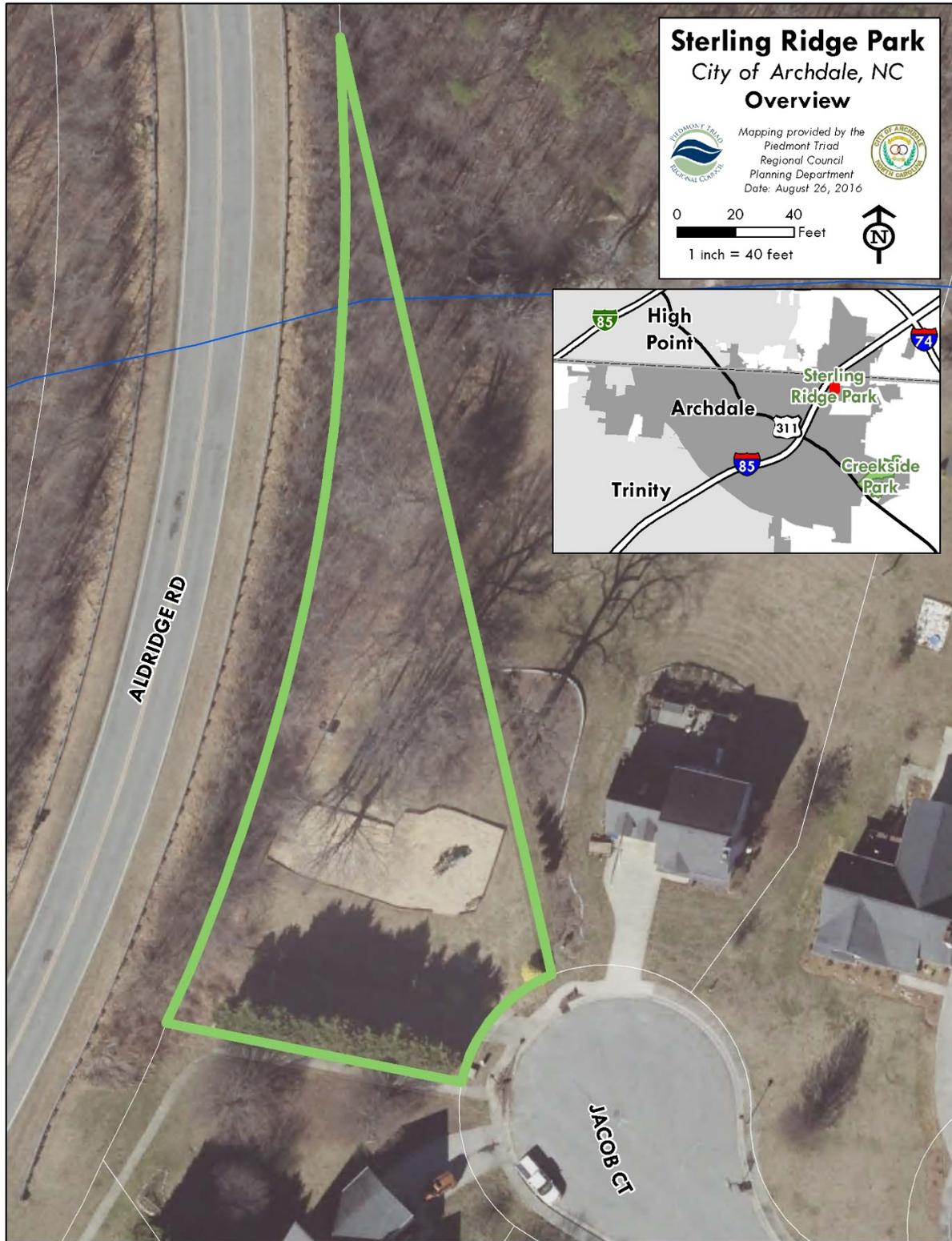

## CHAPTER 4: PARKS AND RECREATION COMPREHENSIVE PLAN

The Archdale Parks and Recreation Department has provided excellent service to the community. However, parks and recreation system service expectations continue to change and develop. The facilities desired by residents and visitors evolve over time. Who would have ever thought of a food truck rodeo or dedicated bark parks 10 years ago? The thought of playing Pokémon GO on your phone and exercising as part of the game is presenting renewed interest and need (by players and non-players) of safe places to be able to recreate, play or even walk. Increasing the density of parks available to citizens provides increased accessibility to nature, which is an important physical and mental refuge from the day-to-day hustle and bustle of today's lifestyle. This parks and recreation plan provides City staff and elected officials of Archdale a guide to making decisions about investment in the future of the Archdale Parks and Recreation system.

Archdale's close proximity to the City of High Point allows recreation facilities in the southern part of this larger City to also serve the residents of Archdale. The proximity of the High Point Allen Jay Recreation Center to the northern part of Archdale, for example provides recreation services including basketball, walking track and open play areas. Therefore, it may appear at first glance that this section of Archdale is underserved if looking just at what the City of Archdale is providing in the northern part of the City. An important element of providing a walkable City is connectivity between parks and open space. This surprisingly little use of land can increase the utility and use of existing

facilities. Several parts of the City are lacking these nodes where greenways connect parks and neighborhoods.

This chapter highlights proposed facilities to add to the parks and recreation system. Most proposed facilities are located at Creekside Park, a large park facility serving as a community park for the northwestern portion of Randolph County. Sterling Ridge Park has little room for expansion, only improvements to existing facilities. The biggest opportunity for Sterling Ridge is better access from Aldridge Road. The proposed facilities outlined in Creekside Park maximize the use of existing park space. Additional facilities for future needs will require additional park space at this location, major grading or purchase of additional park space at a different location. As mentioned in the previous chapter, future neighborhood parks and a downtown park will meet the needs of existing and future residents, providing park acreage to match and exceed the national average of park acreage per capita.

The implementation schedule for the proposed facilities will depend on available resources locally and the amount of grant funding that the City of Archdale can leverage to improve and expand the offerings of the parks and recreation system.

Staffing needs are also outlined in this chapter. As additional programs are added to the Archdale parks and recreation system, staffing levels will need bolstering. The staffing needs suggested in this chapter outline proposed staffing for current unmet needs and short term plan recommendations. It is difficult to plan too far into the future for staff needs, depending on how future facilities are implemented and what programming and maintenance will be required.

A table of short term, mid-term and long term parks and recreation system recommendations and cost estimates will conclude this chapter. The table of project and program improvements is based on public input, survey interests, available resources, existing maintenance needs and project demographic projections.

Facilities estimates are provided based on popular and desired parks and recreation facilities. Additional or different facilities may become desired and this list should not restrict implementation of other types of facilities as opportunities and interests evolve. Facility cost estimates are intended for budget planning and should be refined and verified as facilities are designed and engineered to better reflect changing costs and changing feature demands within each facility type.

## Parks and Recreation Site Specific Plans

Two site specific plans were developed during this Comprehensive Parks and Recreation Plan process. Input into features for these facilities was developed from survey input, public meeting workshops and staff review. The Creekside Park site specific plan identifies several additional features to add to the park, but there are also significant rehabilitation opportunities described below. A Downtown Park conceptual site plan is also provided, which could be located near the center of Archdale to provide a gathering space for outdoor concerts, street fairs and other community events that may support the businesses in downtown, but also provide a location that is walkable and bikeable from existing Archdale neighborhoods.

### Creekside Park Site Specific Plan

The Creekside Park proposed facilities map outlines the parks and recreation facilities proposed over the next 20 years for Creekside Park. Figure 9 provides a graphical representation of the following proposed parks and recreation facilities (not in priority order):

#### New Facilities

- Dog Park,
- Volleyball Courts (2 new),
- Amphitheater,
- Multi-Purpose Fields (2 modifications of existing fields),
- Challenge Course,
- Picnic Shelters (4 new),
- Multi-Purpose and Mountain Bicycle Trail,
- Additional Parking and Lighting,
- Farmer's Market Canopy,
- Splash Pad.

#### Major Capital Expenditures for Improvement of Existing Facilities

- Update and Improve Accessibility for Large and Small Playground,
- New Light Fixtures for Tennis Courts,
- Recreation Center Expansion,
- Pave and Improve Outer Loop Trail,
- Improve Existing Aldridge and Small Picnic Shelter & Bathrooms,
- Relocate Basketball Court,
- Relocate Batting Cages.



## **Downtown Park Plan**

The following downtown park concepts show conceptual recommendations for Archdale to implement a downtown park facility that will draw pedestrian traffic, give a focal point for the City and a place to hold events where availability of pedestrian scale land uses and spontaneous walking and shopping experiences can take place.

### **ACTIVITIES**

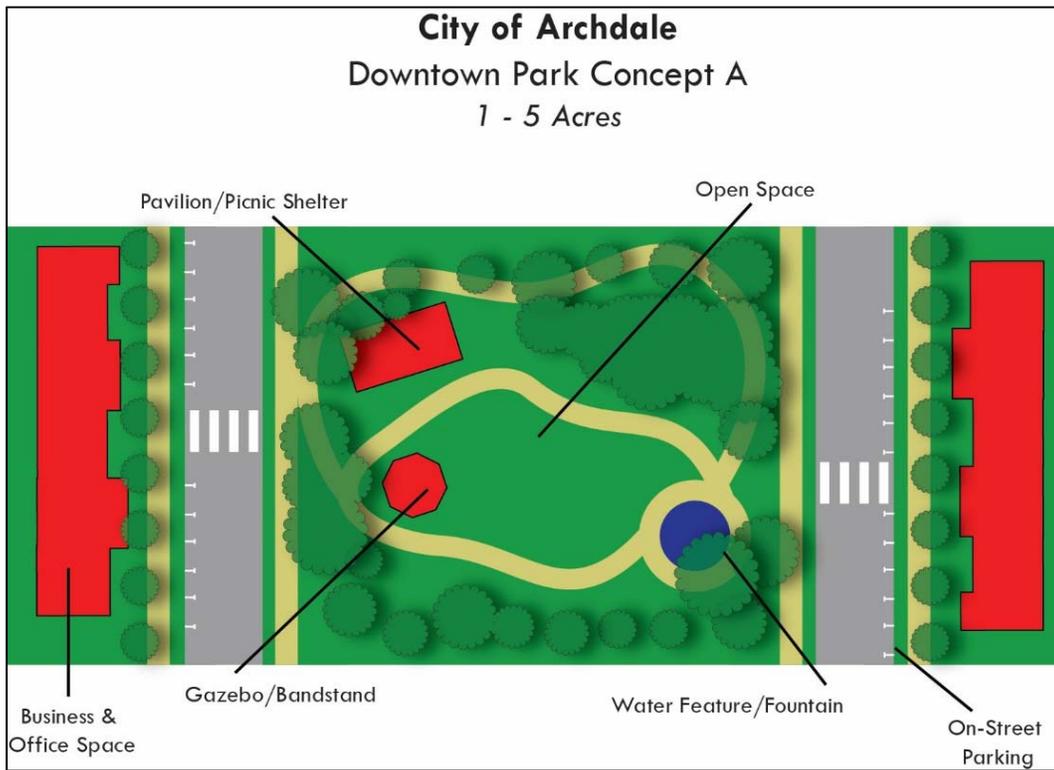
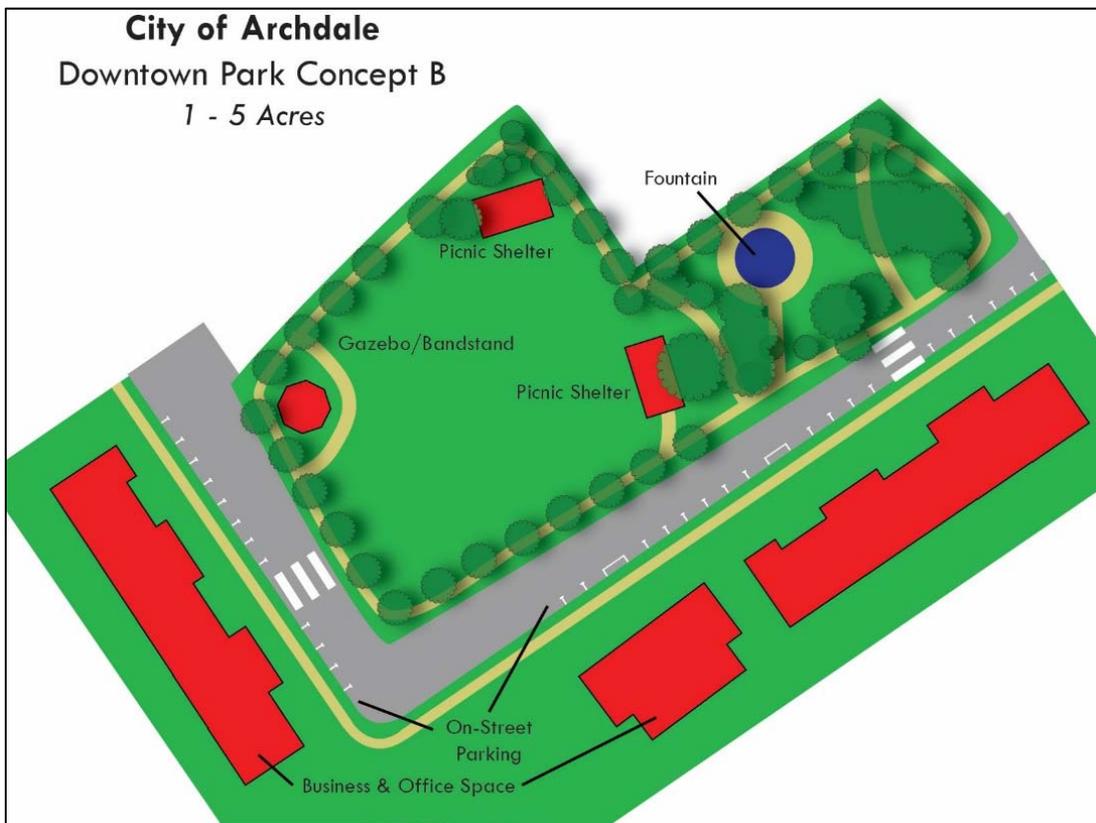


Figure 10: Downtown Park Example – Concept B

A variety of activities are proposed in Concept A (Figure 9) and B (Figure 10). In both concepts, an open space is available along with a gazebo/bandstand, a water feature/fountain, and a place for groups to rent such as a picnic shelter or pavilion. Multi-use trails are also an important component in each concept. It is recommended that surrounding land-uses should complement the activities in the park if possible.

### **PARKING AND TRANSPORTATION**

Both concepts aim to create a safe and inviting space for walking and bicycling while still accommodating parking requirements for motorized vehicles. Sidewalks, multi-use paths, bicycling facilities, and high-visibility crosswalks should be considered in any final site design. Allowing driving from one place to another within the downtown park area should be discouraged along with any vehicular focused land-uses such as banks, restaurants with a drive-through window, or auto repair shops.

Vehicle parking is available in both Concepts A and B through on-street spaces and surface lots (not shown). As a rule, parking should be minimized or hidden enough to not overtake the aesthetic nature of the overall downtown park design. This can be accomplished by positioning parking lots between buildings and screening them with landscaping features.

### **LANDSCAPING AND LIGHTING**

Landscaping and lighting play a role in developing a cohesive space that is visually appealing and safe both day and night. In both concepts, trees play an important role in creating a welcoming environment while also providing visitors shade during the summer months. Proper lighting should consider both site aesthetics and place to aid visitors throughout the year.

## Department Staff Overview

A review of the parks and recreation department staffing needs was conducted in September 2015 with the Parks and Recreation Director. The following questions guided discussion on staff needs:

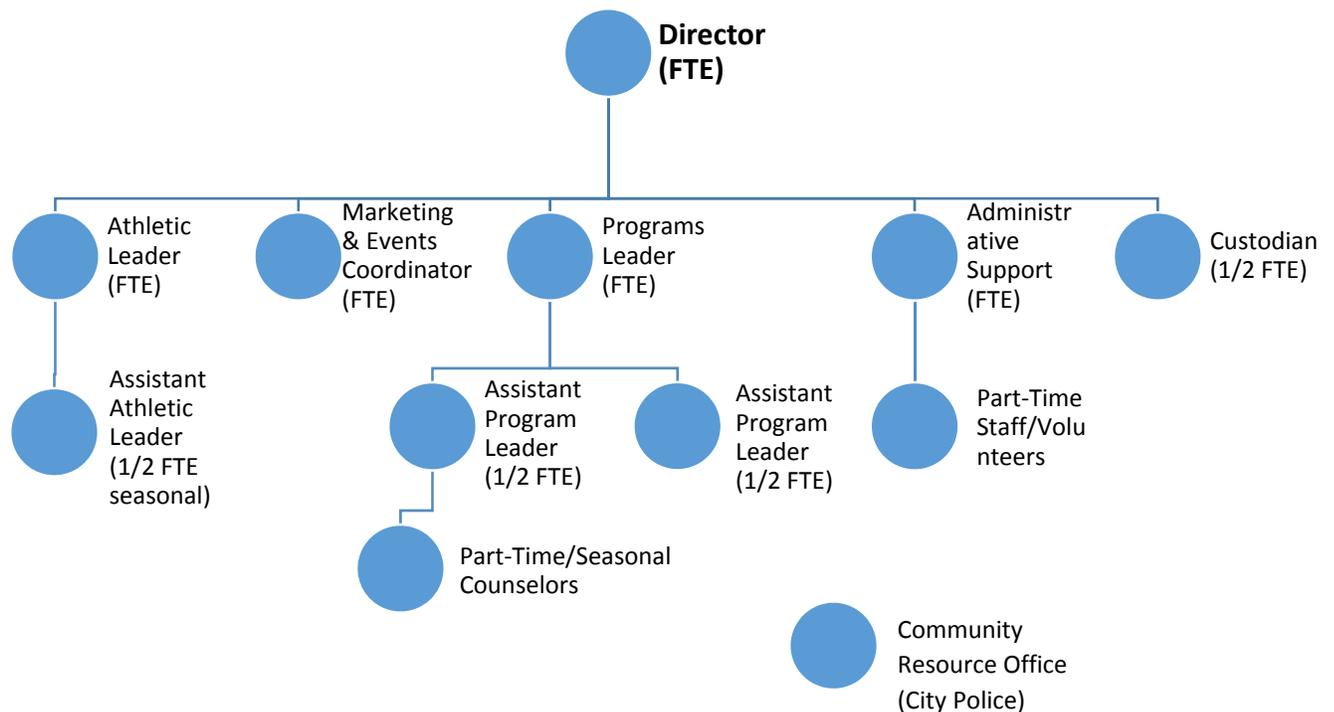
1. What are existing staff training needs?
2. What are existing parks and recreation board training and capacity building needs?
3. What are staffing needs or gaps?
4. Are there other issues?

The current staffing consists of:

- Five (5) full-time employees
- Three (3) part-time employees, 1/2 full time equivalent (FTE)
- One (1) part-time seasonal employee, 1/4 FTE equivalent

Several volunteers and hourly employees cover the Recreation Center during evening and weekend hours and are not included in the Organizational Chart below. The City Police provide a uniformed Community Resource Officer based out of Creekside Park.

## Parks and Recreation Programming Needs

### Staff Training Needs

Educational training and continuing education helps employees provide the highest level of service to the citizens of Archdale. Each employee does not have a specific training schedule, but training is included in the annual Parks and Recreation budget at \$3,000 for FY 16. When employees are in need of professional development hours, funding can usually be found to cover training and travel needs at the current budgeted amount.

### Board Capacity Building Needs

The staff needs a better understanding of what board needs are and what can be done. The following are recommended activities to build capacity at the advisory board level:

- Conduct a board retreat to encourage relationship building between staff and the board (e.g. field trip to example recreation facility);
- New board member packet with a training video, webinar and/or PowerPoint presentation
- Items the parks and recreation advisory board could assist staff with:
  1. Advise on new policies before sending to the City Council;
  2. Collaborate on capital improvement project ideas;
  3. Be tapped for volunteering at special events (farmer's market, 4<sup>th</sup> of July, Halloween festival); and
  4. Support and promote a fundraising campaign for specific projects.

### Future Staffing Needs

The following two part-time positions are recommended to support existing full and part-time staff with day to day duties. Additionally, reclassifying the Assistant Program Leader position is recommended to keep and retain good talent.

- Assistant Athletic Leader (**New Position, ½-3/4 FTE**)
  - Duties: Monitor volunteer coaches, parents and participants on ballfields and maintenance of fields (e.g. line striping, raking, etc.). This position would allow the

Athletic Leader to better plan, budget and market athletic programs. The Athletic Leader is periodically over-extended.

- Marketing & Events Coordinator Assistant (**New Position, ¼ FTE**)
  - Duties: Help at large events for set-up, breakdown and tabling. This position would be seasonal and temporary. Current staff is looking at local school and University internship programs to fulfill the need.
- Assistant Program Leader (**Re-Classification of Existing Position**)
  - Need additional training and capacity building, best met with a higher base rate of pay to attract and retain part-time support that can better manage after school care, summer camps and other activities

#### Other Staffing Issues

The Archdale Building and Grounds department is responsible for grounds maintenance at Creekside, Sterling Ridge Park and many other City properties and facilities. As services and amenities continue to increase, staffing will need to also increase to meet the maintenance demand.

## Site Suitability for Future Park Expansion

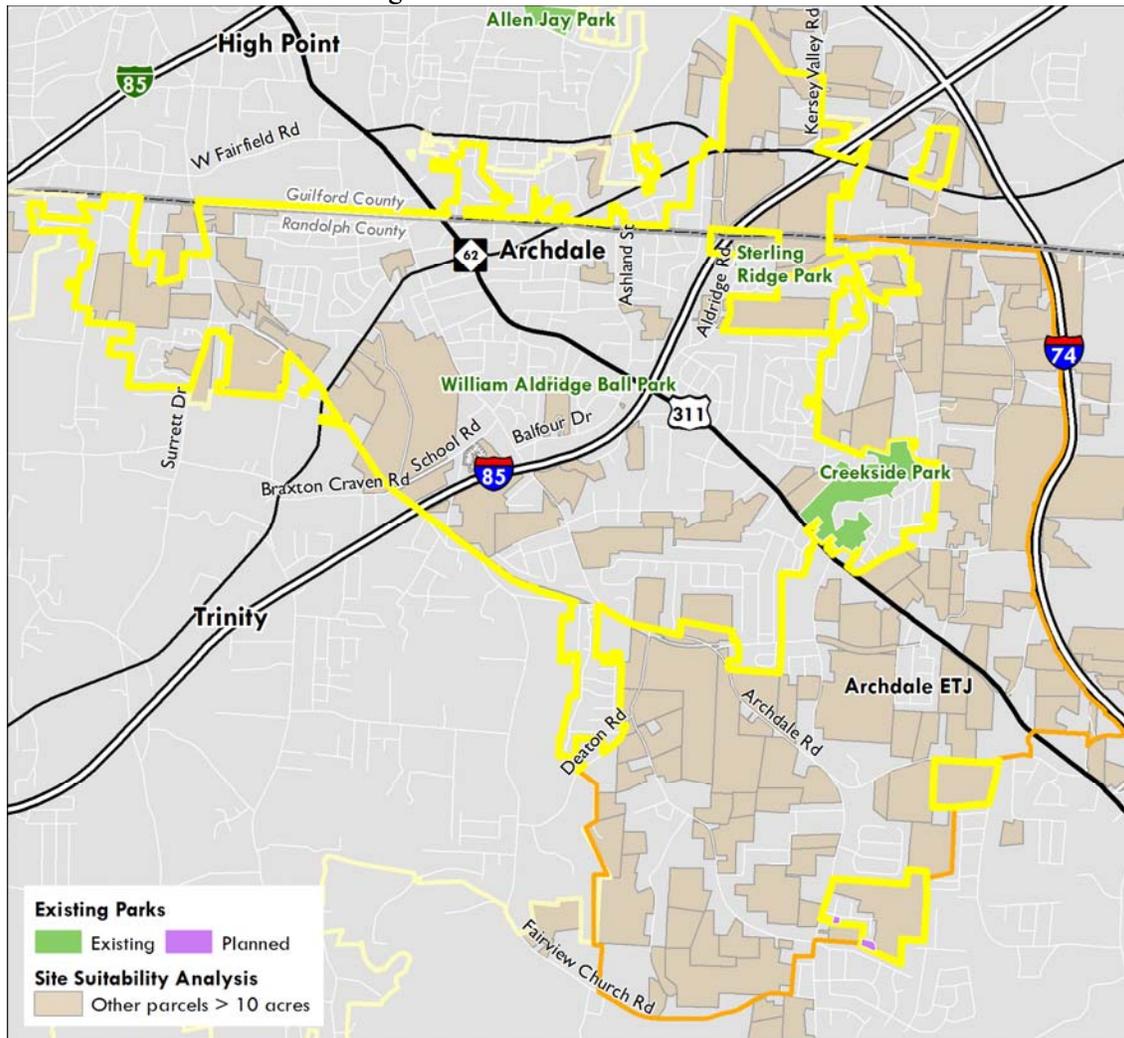
Parcels in and around Archdale were analyzed for potential new park locations using a Geographic Information System. The following criteria was used to select parcels:

- Size (10 acres or larger)
- Land Use (Undeveloped)
- Road Access (Yes/No)
- Environmental Constraints (wetlands (y/n) & slopes <20%)
- Distance from Current Parks (proximity)
- Containing Lake or Stream (Yes/No)
- Surrounding Residential Population (proximity)

### Proximity and Size

Only large parcels greater than 10 acres in size were considered. Large parcels within one-quarter mile of the city limits and ETJ boundary were selected, but those falling within the jurisdictions of High Point or Trinity were excluded.

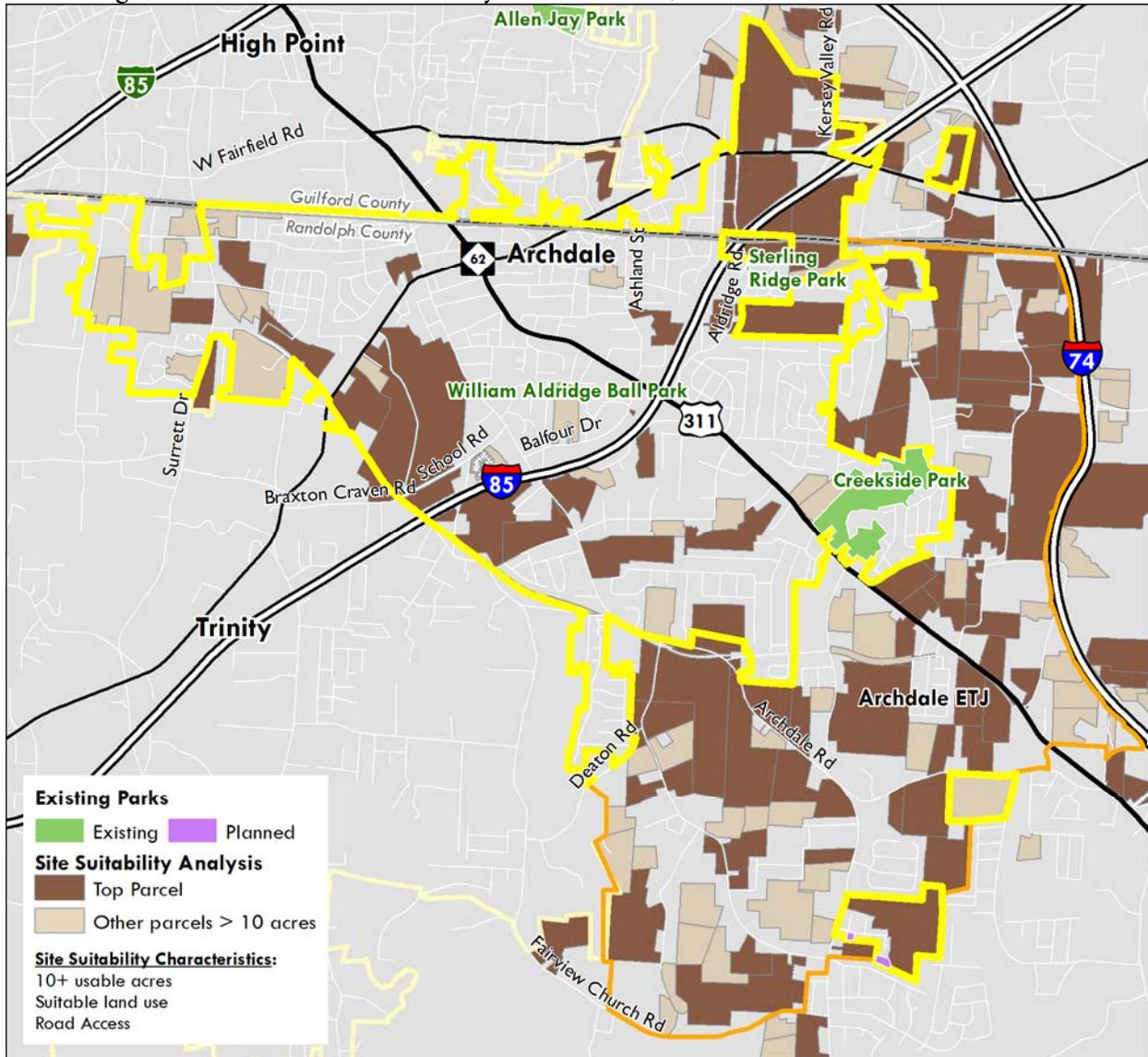
Figure 12: All Potential Park Parcels



### Land Use, Access and Environmental Constraints

The land use of each potential parcel was determined as either not suitable due to existing infrastructure covering all or most of the parcel, suitable if undeveloped, or suitable if subdivided if the parcel contained at least 10 acres of undeveloped space. Parcels with a suitable land use (or suitable if subdivided) were then analyzed for access by an existing road. Suitable and accessible parcels were further analyzed by amount of usable acreage. Land in wetlands and with steep slopes greater than 15% were excluded from usable acreage. Only parcels with 10 acres of usable land, with road access and with suitable land use are shown in brown below.

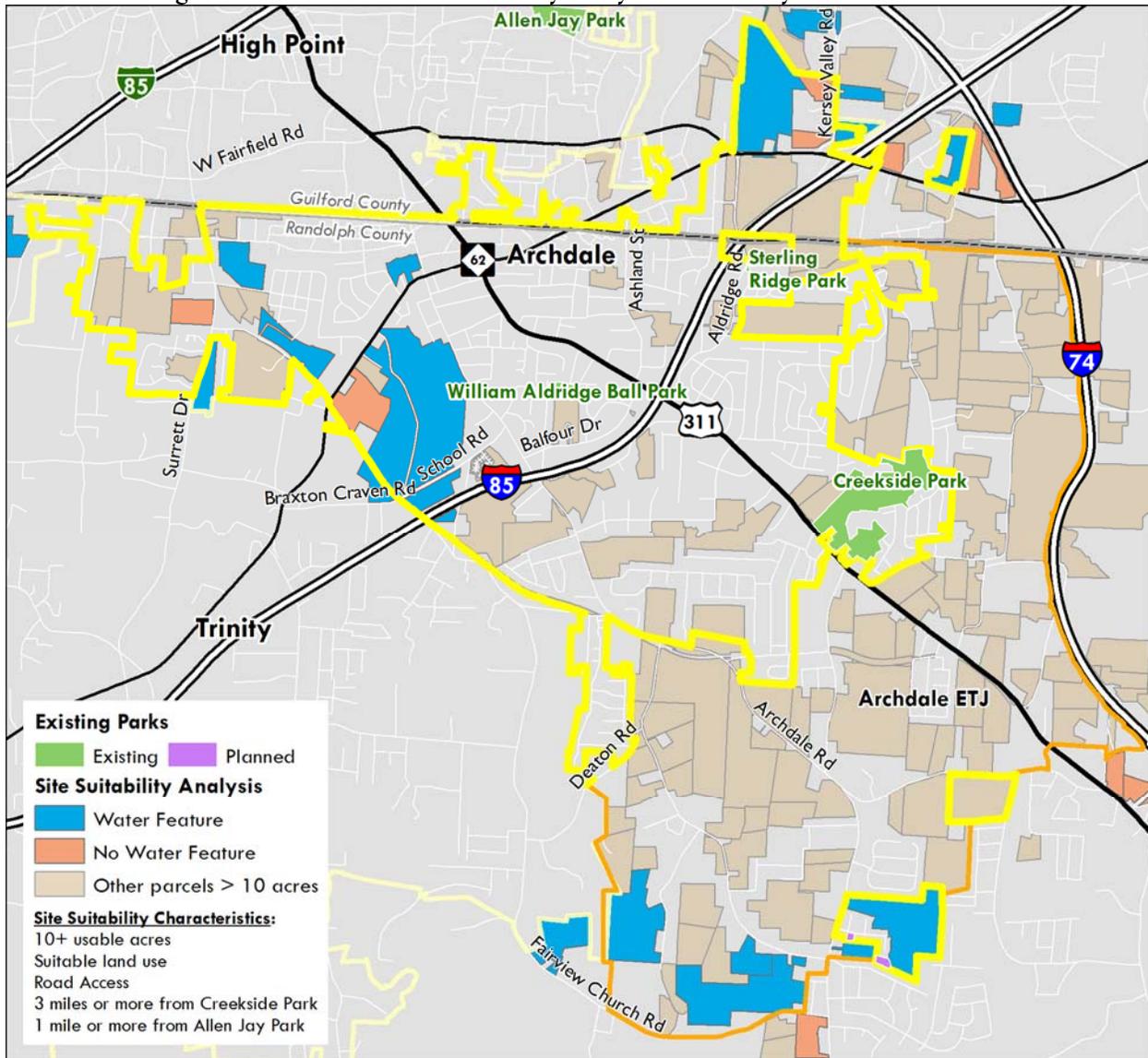
Figure 13: Potential Park Parcels Analyzed for Land Use, Access & Environmental Constraints



### Distance from Current Parks and Water Features

A better location for a new community park is one not in close proximity to Creekside Park or the Allen Jay Park in High Point. Distance from both of these parks were determined for all parcels with at least 10 acres of usable land, with road access and with a suitable land use. Parcels at least one (1) mile from Allen Jay Park and three (3) miles from Creekside Park were deemed suitable. Parcels are shown in blue if they also contain a lake or stream and in orange if there is no water feature on the property.

## Proposed Parks for Future Expansion

In addition to completing a land suitability analysis for future park locations, the existing and future service areas of park locations is provided below. Creekside and Sterling Ridge Park are shown as well as the Allen Jay Recreation Center. Schools and their associated facilities and service areas are provided as well to demonstrate their utility to adjacent neighborhoods. The Proposed Parks map is not intended to prescribe exact locations of park facilities, but will provide a guide for future locations based upon recreation standards and future park expansion goals established in Chapter 3: Existing Conditions and Standards.

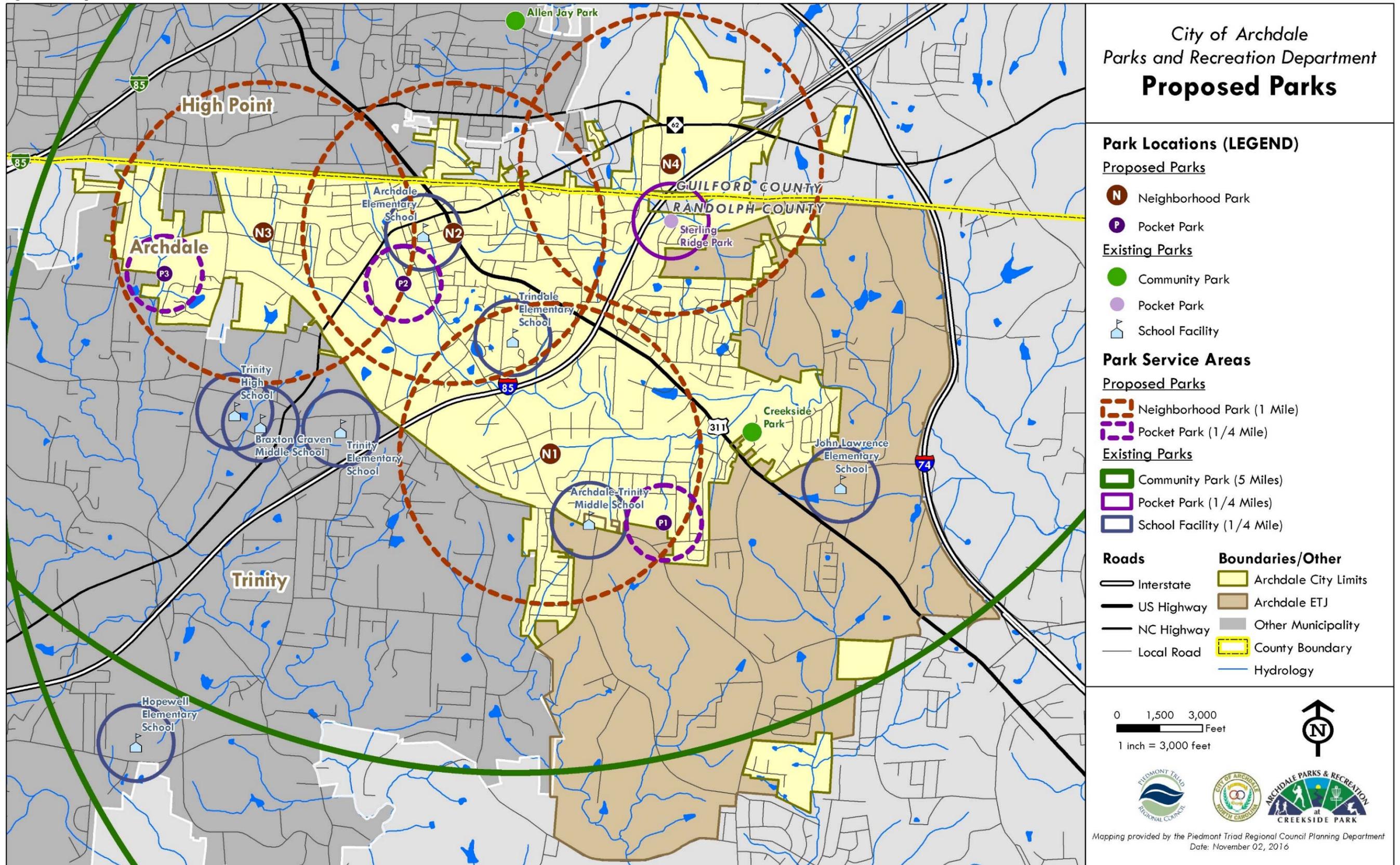
There are three pocket parks and four neighborhood parks proposed over the next 10 to 20 years for the City of Archdale. The goal of adding 30 additional acres over the next 10 to 20 years will be achieved if more locations are spread out across the City of Archdale. Additional locations will encourage walking or bicycling to park locations, provide health benefits, and also provide equitable access to park locations to serve as neighborhood gathering places.

Resources should be set aside for park land acquisition to take advantage of opportunities to purchase available real estate in underserved areas of the City of Archdale. As properties are acquired, resources to establish site specific park and stewardship plans should be budgeted to insure design and features developed fit the specific property, but also respond to the parks and recreation needs and desires of adjacent neighborhoods.

The implementation schedule does not include all expenses for the Parks and Recreation Department, replacement and repair of existing moveable equipment and existing operating budget is excluded to focus on new capital needs.

Access to resources and changing conditions will influence cost, timing and prioritization of recommended facility improvements. If there are opportunities for project specific grants or earmarked donations for long-term priorities, the schedule shown above should be changed. Additionally, the schedule should be revised on an annual or bi-annual basis as projects are built and completed and cost inputs change due to inflation or commodity price swings.

## APPENDIX A: SURVEY RESULTS

The Parks and Recreation Survey was distributed between late June 2015 and July 24, 2015. There were 297 households who began the survey, with 74% of respondents living in Archdale. Approximately 260 completed survey questions from all 5 sections of the survey. The surveys were distributed via the following methods:

- Parks and Recreation Department's e-mail newsletter;
- City of Archdale Parks and Recreation web page link;
- Inserted into the City's water bill;
- An advertisement was taken out in the Archdale – Trinity News in late June 2015; and
- Distributed at special events and key civic locations (e.g. City Hall, Library and Recreation Center).

To incentivize responses two gift cards and a gift basket were offered to individuals who completed the survey before July 24, 2015. These prizes were distributed to three randomly selected survey respondents in mid-August 2015. The following is a summary of the survey results. The full results with tables and graphs can be found in the Appendix.

### Section I: Archdale Parks Area Use

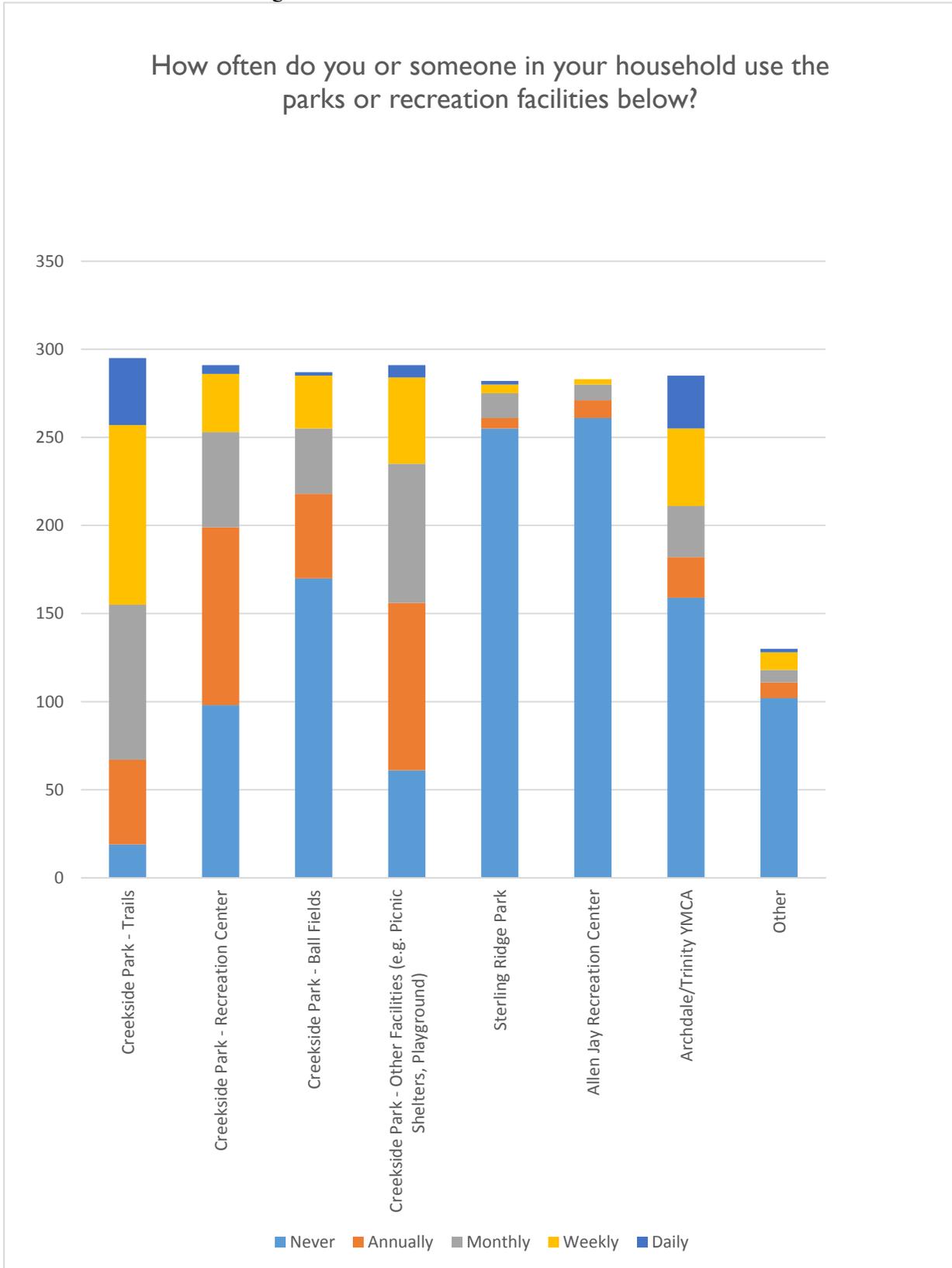
#### **Question 1: How Often Do You Use the Recreation Facilities?**

According to survey responses, the Creekside Park Trails and the Recreation Center are the most visited locations. The Creekside Park Trails are the most visited locations with 38 daily visits and 102 weekly visits. The Allen Jay Recreation Center was the least visited facility with 261 out of the 283 responses reporting that they have never been to the facility, Sterling Ridge Park was the least visited park with 255 of the 282 responses saying they have never been to the park.

## Section II: How Do You Recreate

### Question I: How Do You Recreate? Games & Activities

Respondents are allowed to check more than one option. There were 196 responses relating to games and activities. Cornhole was top choice with 135 responses or 68.9% and Yard games received 102 responses or 52.0%. Miniature golf also received 86 responses or 43.9% of the respondents played miniature golf within the parks and recreation facilities in Archdale. Disc golf was also popular among the individuals who took the survey

## Question 2: How Do You Recreate? Arts Activities

According to the results, 212 of the 297 respondents answer this question pertaining to the Arts. Each respondent could select more than one choice for this question. Concerts received the most interest with 67% or 142 of the responses indicating that they enjoy the concerts offered, the arts/craft show tied for 2<sup>nd</sup> with library events both with 49.1% or 104 out of 212, of the responses to the Art question. Outdoor drama was the least popular art activity with only 17.9% or 38 of the responses. Figure 3 represents a bar graph of the responses in Table 13 drama/theater as well as ceramics/pottery had roughly the same response count at 25.5% and 24.1% or 54 and 38 respectively.

**Question 3: How Do You Recreate? Athletics**

There were 199 responses to this question. The A stands for adult and the Y stands for youth and each individual who took this survey could respond to multiple entries for this question. The most popular sports related activity was swimming with 60.3% or 120 of respondents participating in swimming. Adult Base/Softball and Youth Base/Softball had the highest response count for both of their respective groups; Adult Base/Softball had 16.1% or 32 responses and Youth Base/Softball had 34.7% or 69 responses.

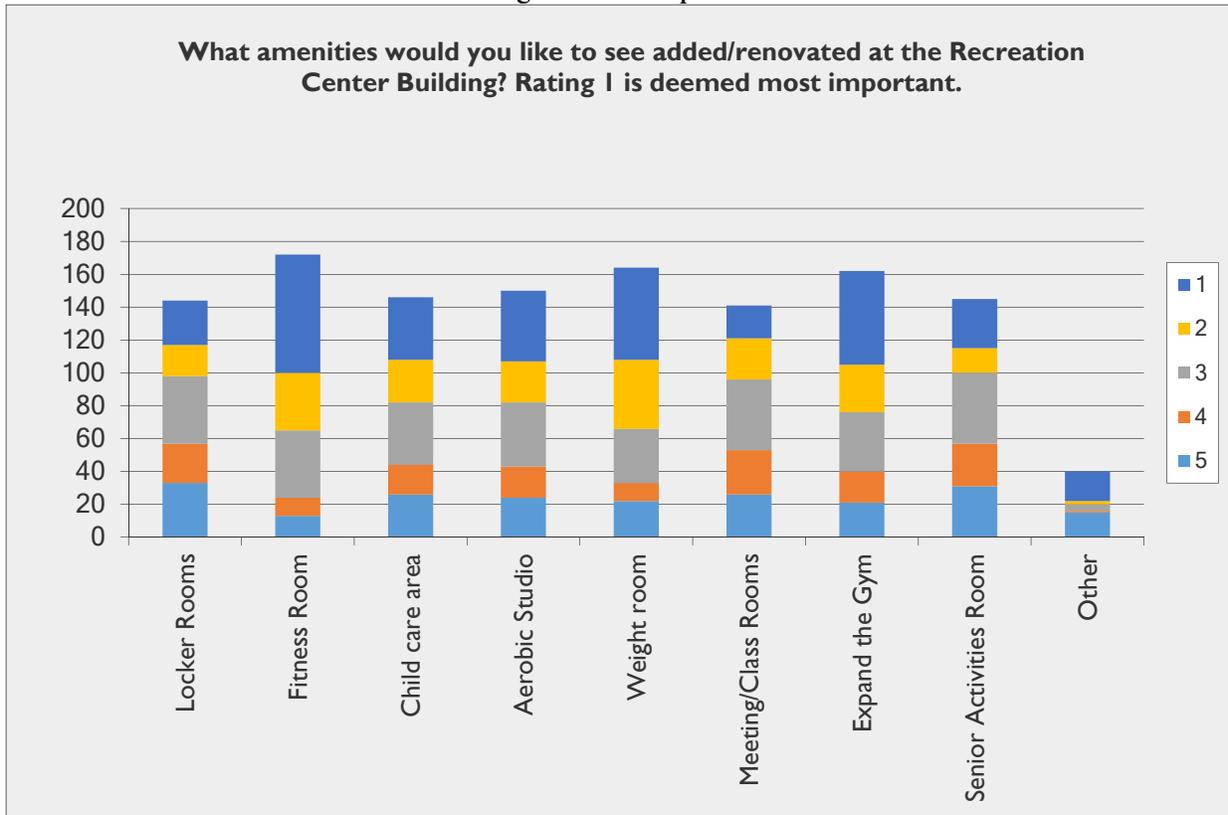
**Question 2: What amenities would you like to see added/renovated at the Recreation Center Building? 1 Being most important.**

Figure 17: What Amenities Would You Like To See Added/Renovated At The Recreation Center Building? 1 Being The Most Important.



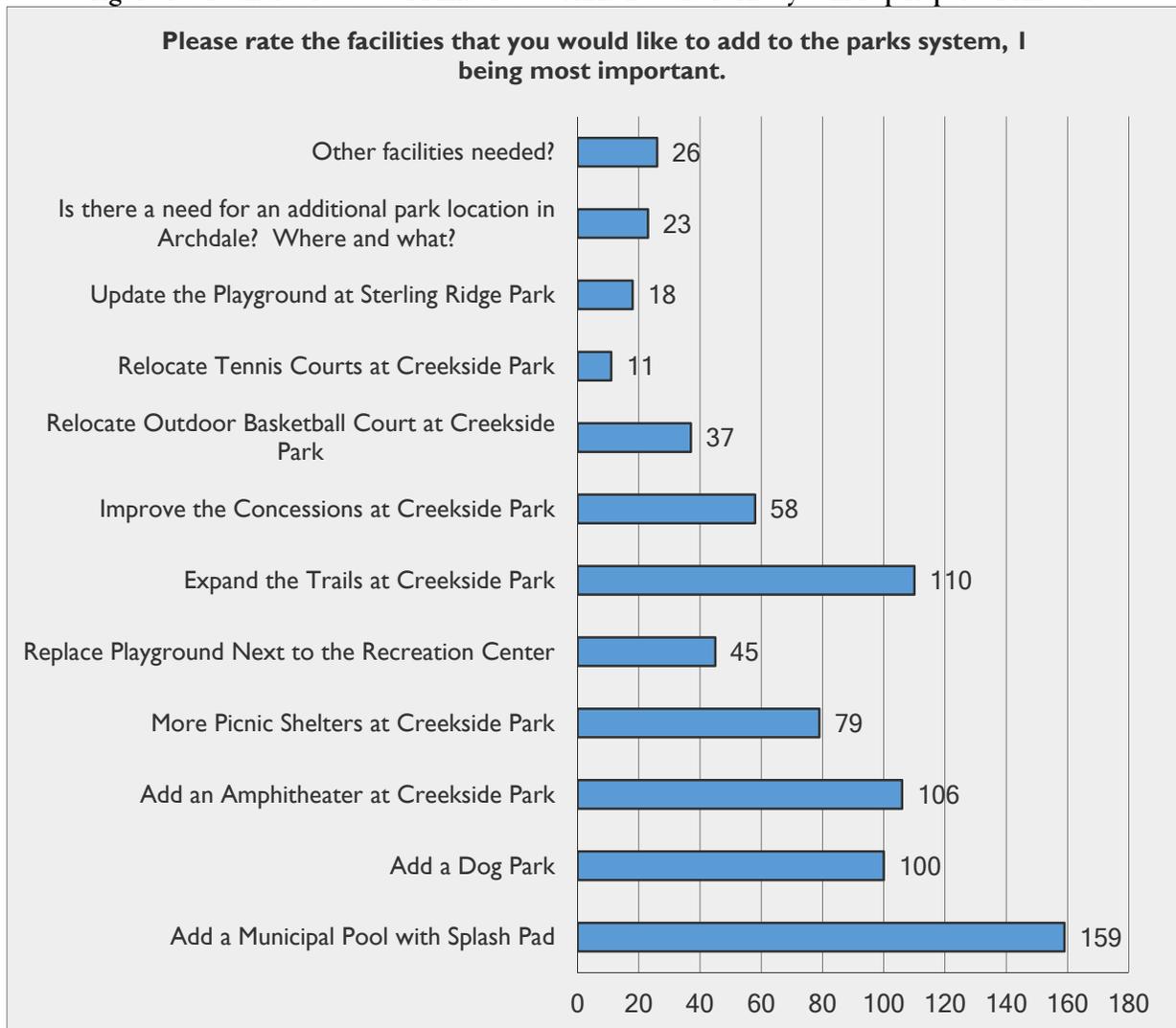
**Question 3: Facilities to be added to park system, rank by using 1 as the most important.**

Figure 18: Facilities You Would Like To See Added to the Parks System Top Reported Answer



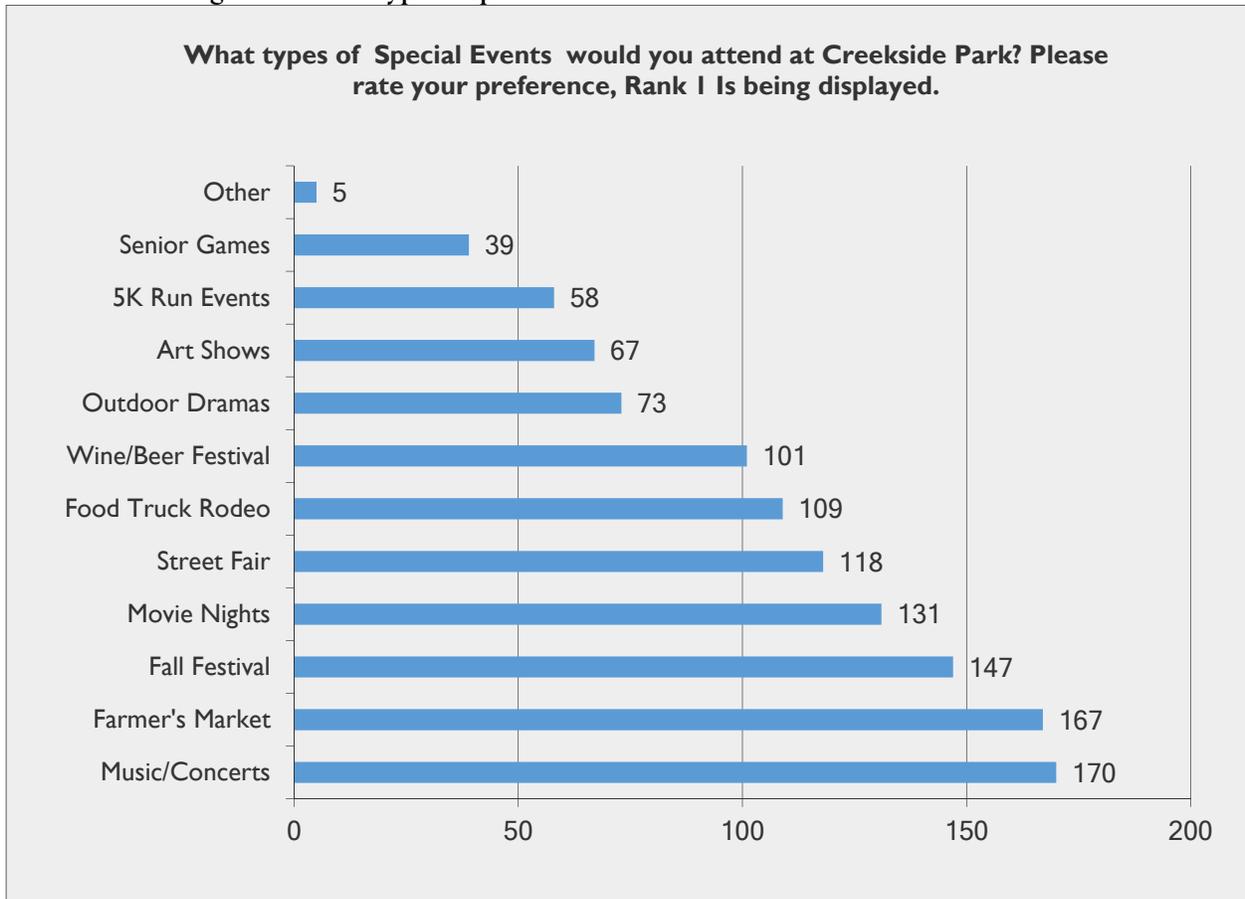
**Question 4: What type of Special Events would you attend at Creekside Park? One being the most important**

Figure 19: What Type Of Special Events Would You Attend At Creekside Park?



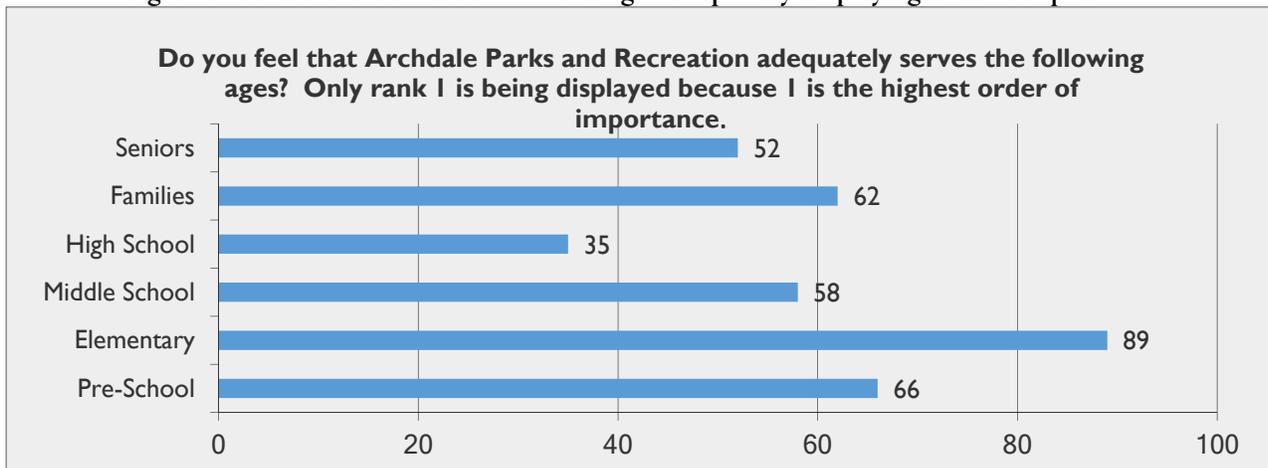

Figure 20: Archdale Parks And Recreation Age Group: Only Displaying Rank 1 Responses



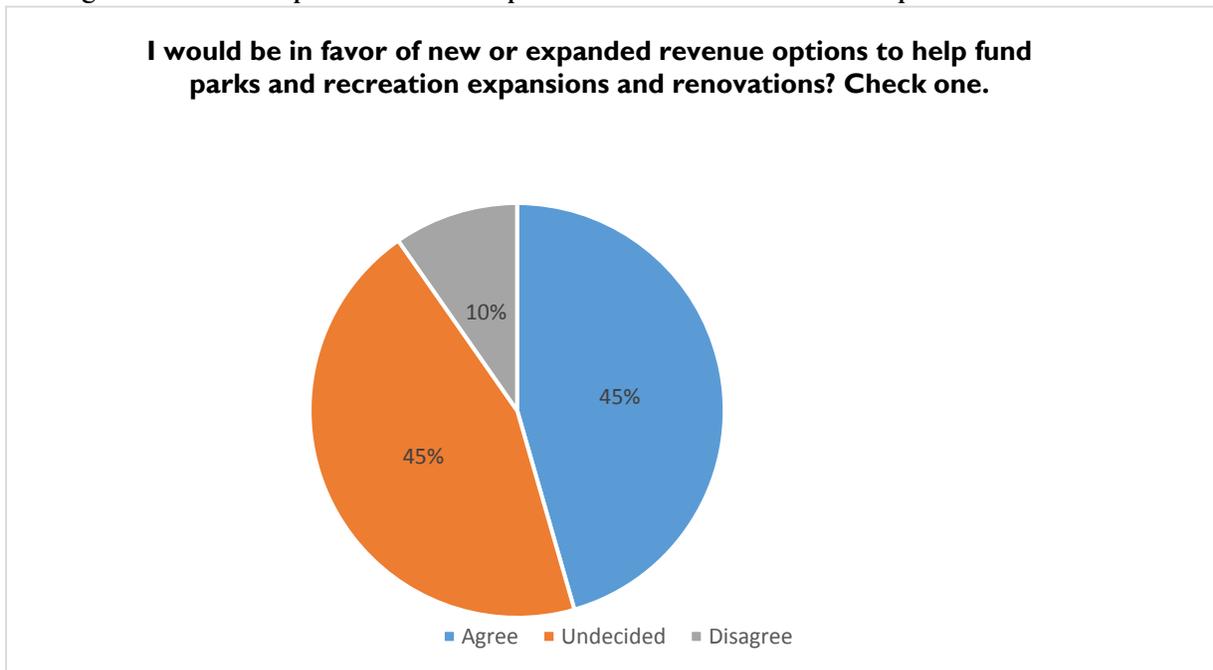
**Question 6: I would be in favor of new or expanded revenues options to help fund Parks and Recreation expansions and renovations?**

Figure 21: New or Expanded Revenue Options for Parks and Recreation Expansion or Renovation?



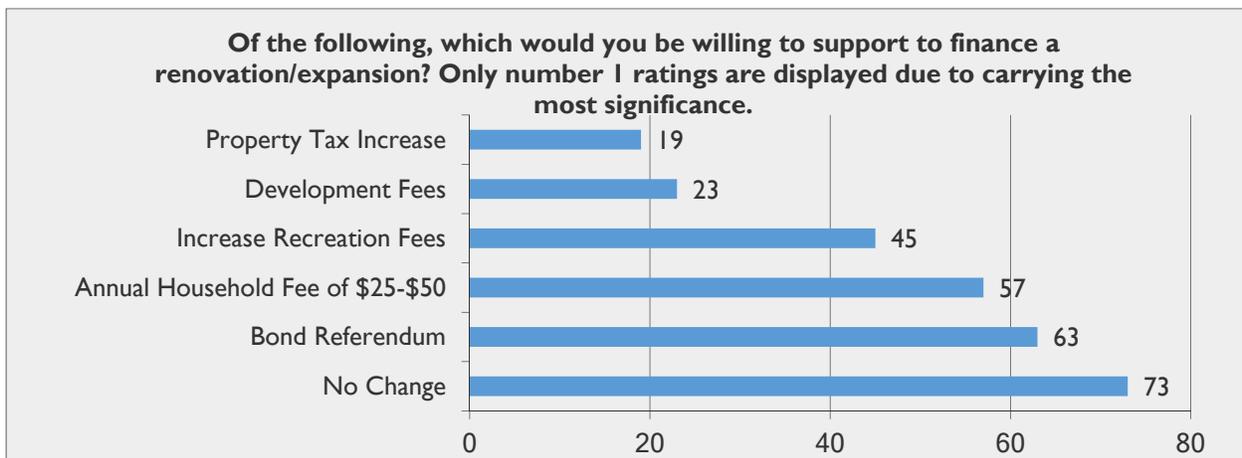

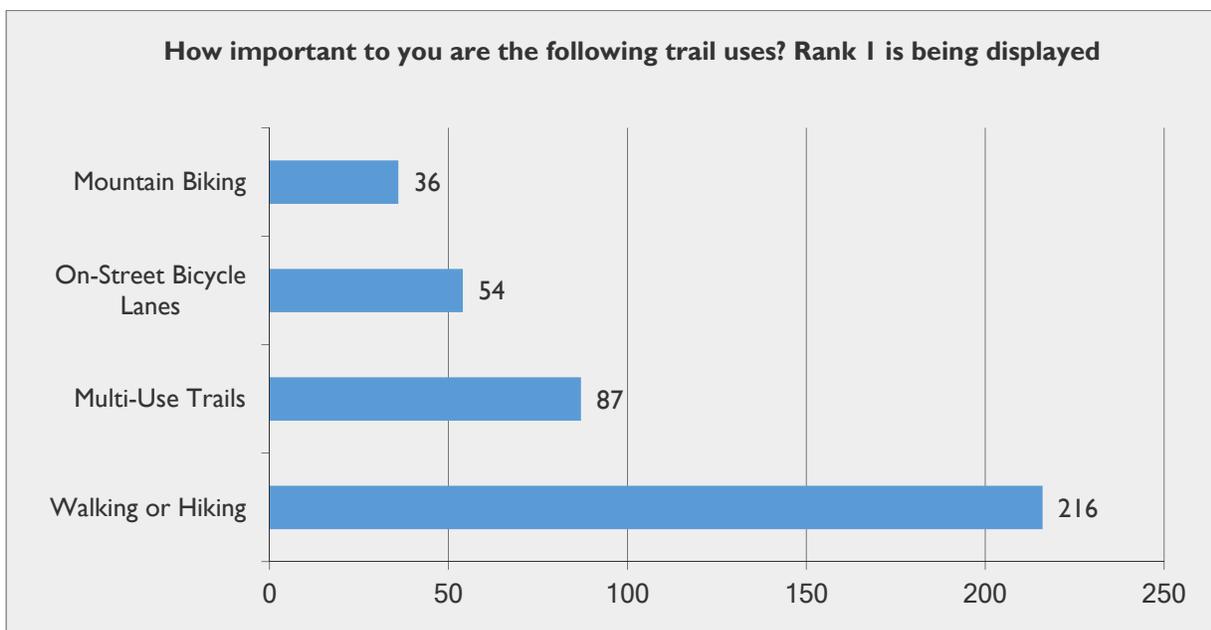

Figure 23: Trail Uses Ranked By Importance, Top Choice Only



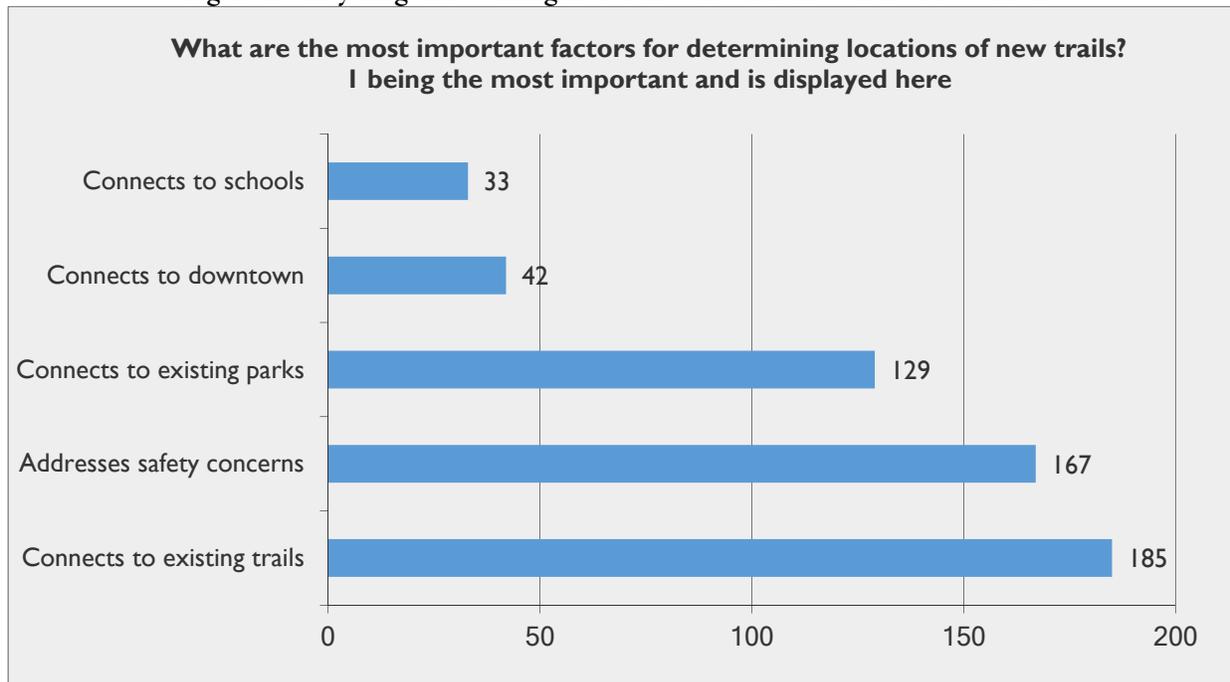

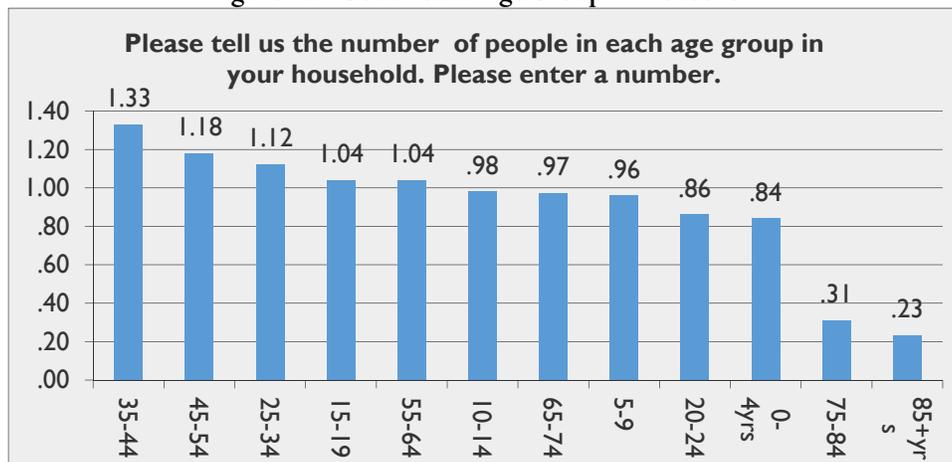

Figure 25: About You... Age Group In Household



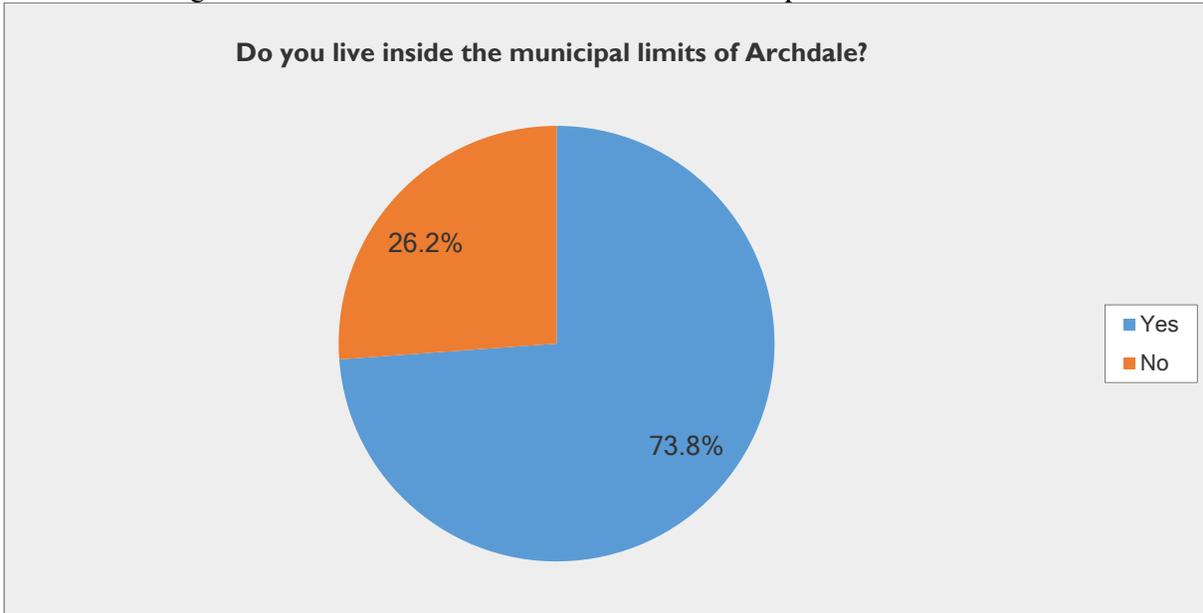

Figure 26: About You.. Do You Live Inside The Municipal Limits Of Archdale?



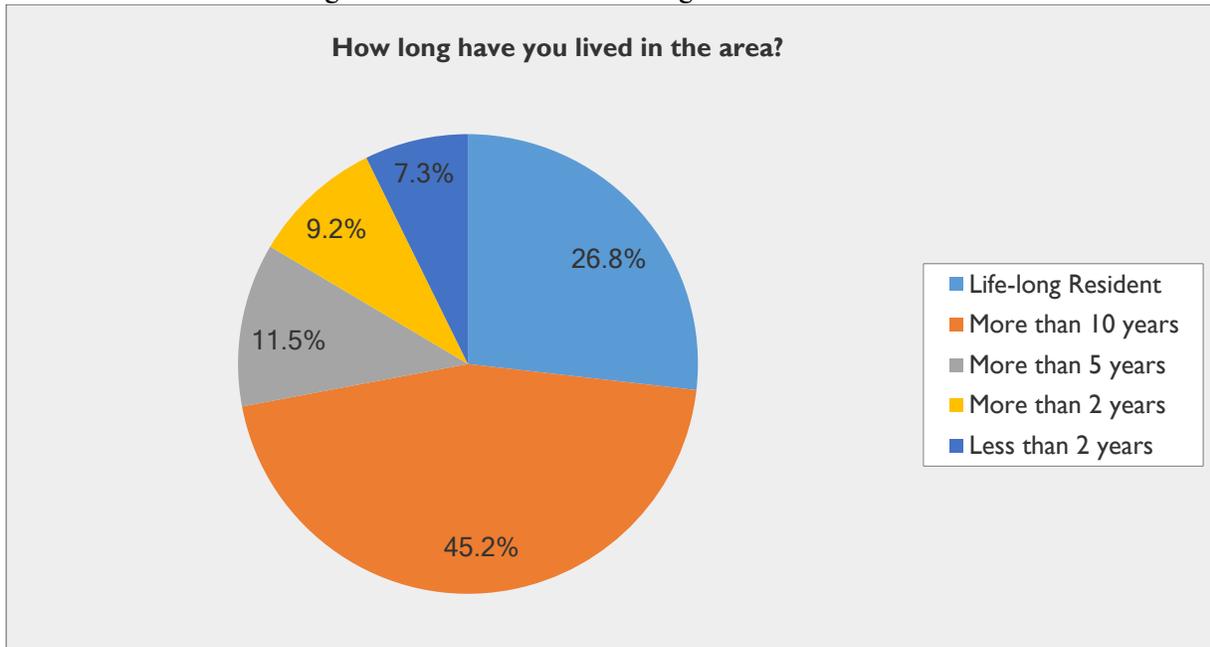

Figure 27: About You... How Long Have You Lived Here?



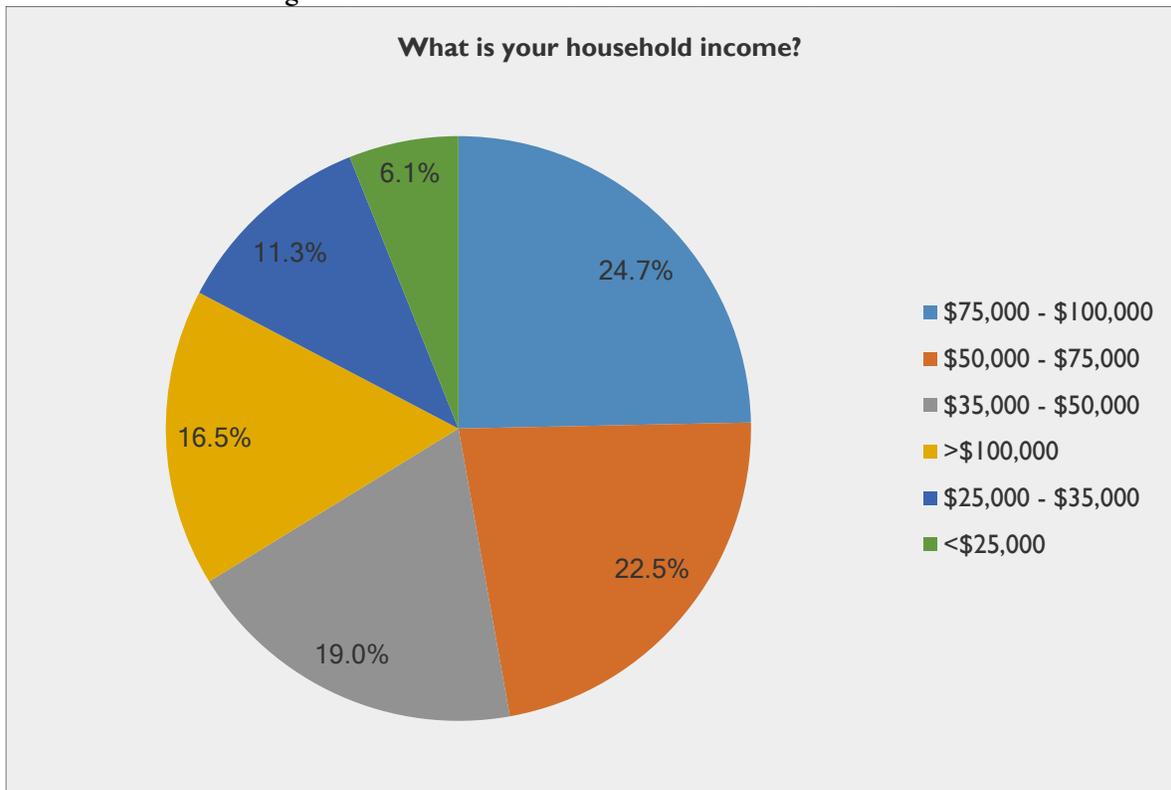

Figure 28: About You... What Is Your Household Income?



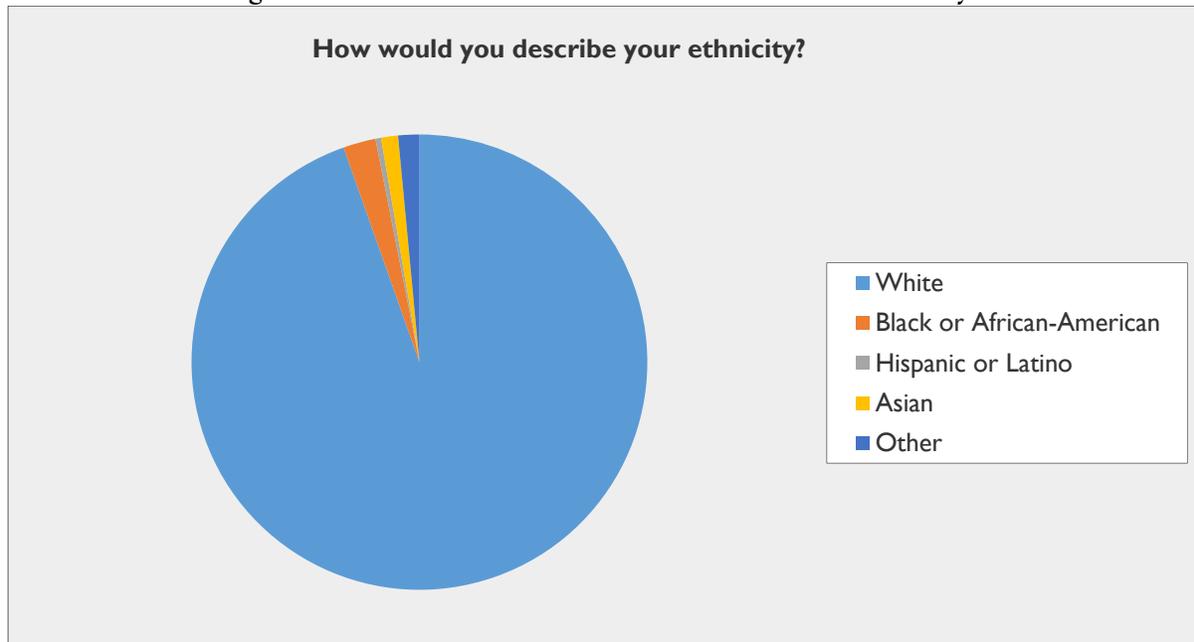

Figure 29: About You... How Would You Describe Your Ethnicity?



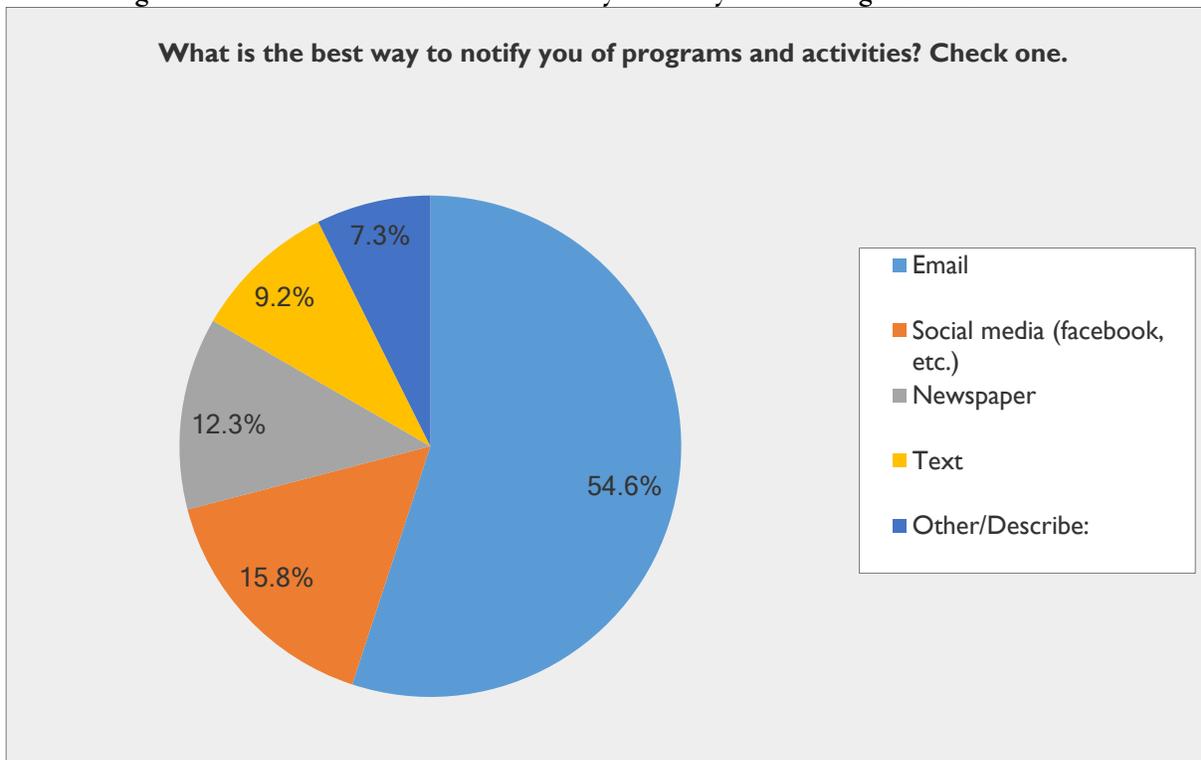

**APPENDIX B: FACILITY AUDIT**

A field audit of existing recreation sites operated by the City of Archdale was conducted as part of the Parks & Recreation Needs Assessment. The audit was conducted jointly by PTRC and local recreation staff on September 24 and 25, 2015. Creekside Park, the Recreation Center and Sterling Ridge Park were reviewed. Characteristic ratings and conditions of each park facility was completed in the following areas (if applicable):

<b>Natural Areas</b>	This category includes open play fields and undeveloped areas within the park boundaries.
<b>Leisure Facilities</b>	This category includes facilities such as picnic shelters, playgrounds and other non-competitive, man-made features.
<b>Recreation Facilities</b>	This category includes facilities such as ball fields, courts and other active facilities.
<b>Access &amp; Parking</b>	This category includes pedestrian, bicycle and vehicular linkages to and through the site, and supporting parking facilities.

<b>Comfort &amp; Amenities</b>	This category includes tangible elements including restrooms, staff offices, maintenance facilities and other support services located within the park site and intangible elements including general patterns of use, visual quality and overall experience.
<b>Opportunities</b>	This category includes the consideration and identification of recreation improvements at each site.

Facility conditions were rated on a scale of 1-5, with 1 being highest and 5 being lowest.

**Summary**

The facilities that Archdale Parks and Recreation maintains appear to be in good condition, however the age of the Recreation Center and the playgrounds at both Creekside and Sterling Ridge are in need of updating. In addition, at Creekside Park the picnic shelter area is in need of new ground cover and the small shelter should be replaced or repaired, as it is structurally unsound. The walking trails, disc golf course and natural areas of the park are very popular and provide a unique park experience.

**Audit Rating Summary**

Facility conditions were rated on a scale of 1-5, with 1 being highest and 5 being lowest. Shown below are the average ratings for the 8-12 statements about condition or quality of particular features in each category (e.g. natural areas).

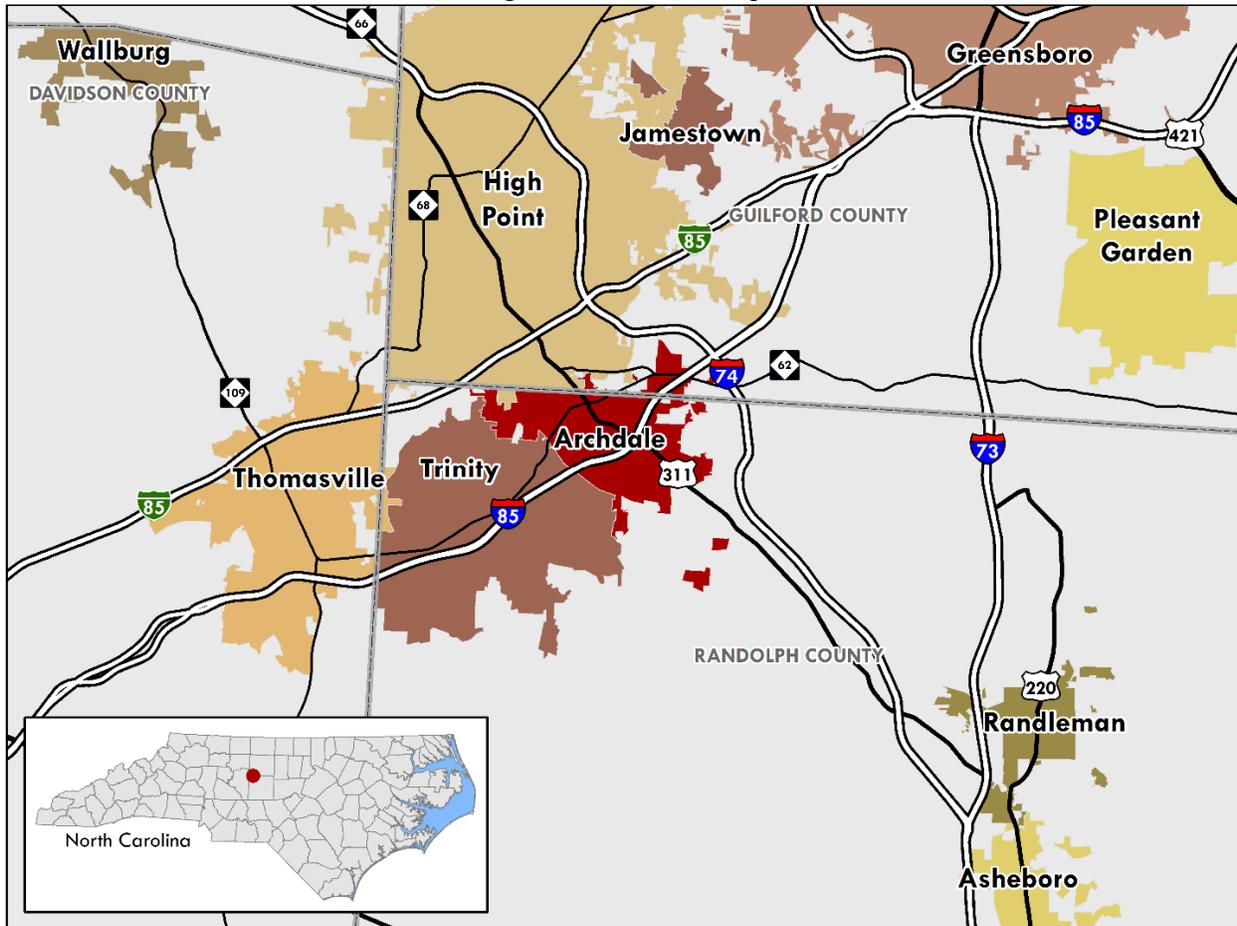

## APPENDIX C: DEMOGRAPHIC REPORT

### Location

Archdale is located along the I-85 and US-311 business corridors in northwest Randolph County. The northern part of the City extends into Guilford County. The City is adjacent to Trinity in the southwest and to High Point in the northwest. Currently, Archdale has a population of 11,852 (2014 NCOSBM), is 8.3 square miles in size and has a population density of 1,412 people per square mile.

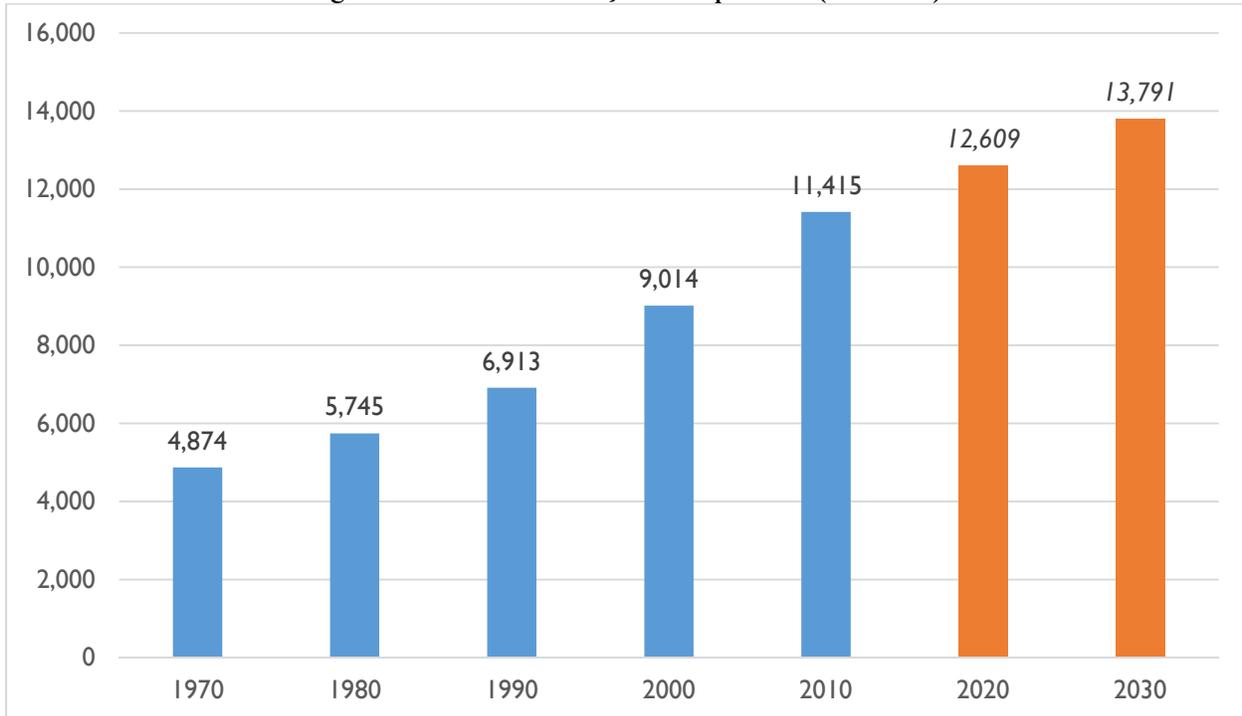
Figure 31: Overview Map



## Population & Growth

In 2013, the certified population estimate for the City of Archdale was 11,852, a slight increase from the 2010 decennial population of 11,415. Archdale saw the highest amount of growth in the 1990's with an annual growth increase of 3% each year. The population growth has since slowed down with an annual increase of approximately 1% each year between 2010 and 2014. Municipal level population projections were estimated by applying the 1% annual growth each year until 2020, and then decreasing the annual growth rate to 0.9% until 2030.

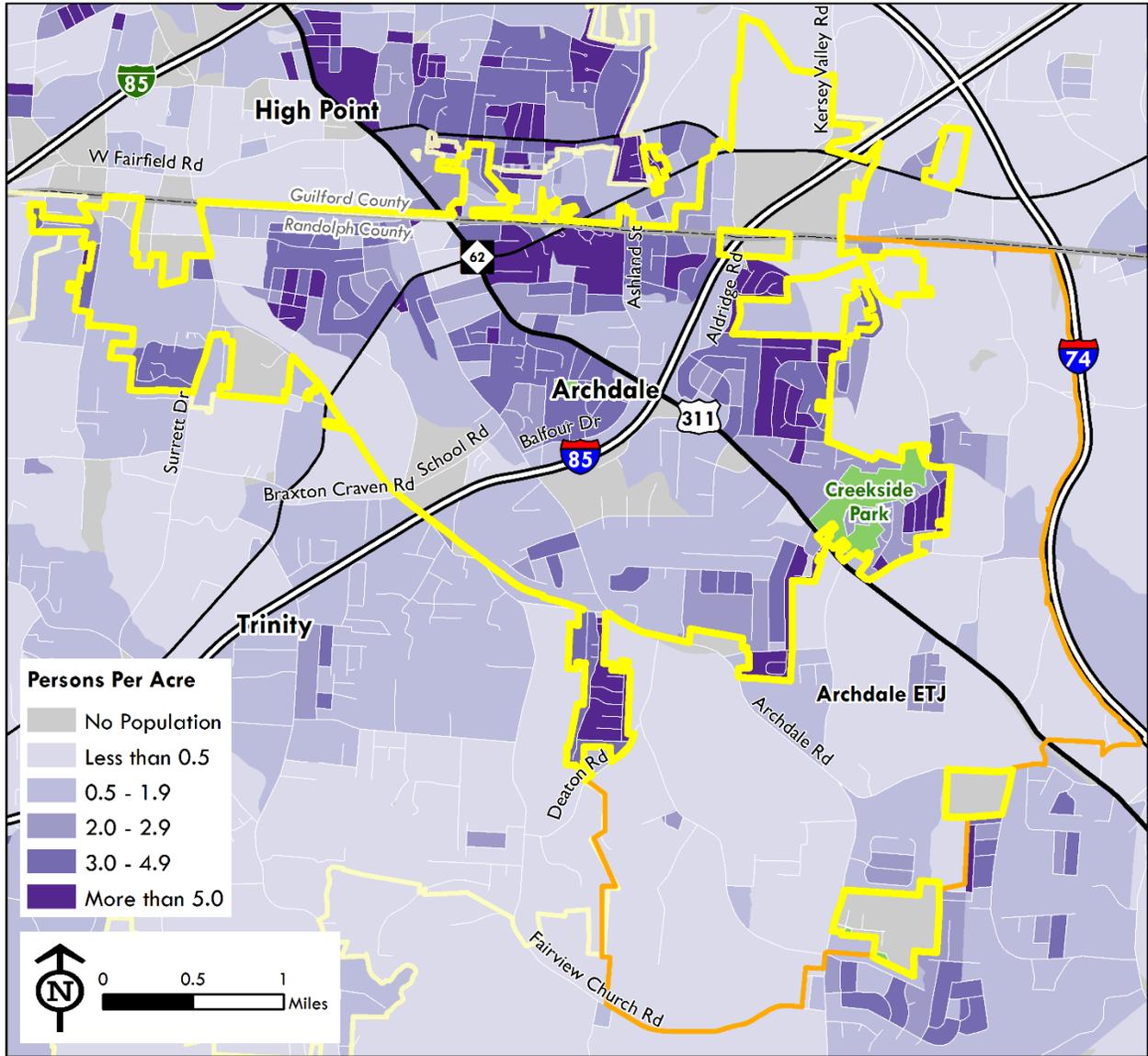

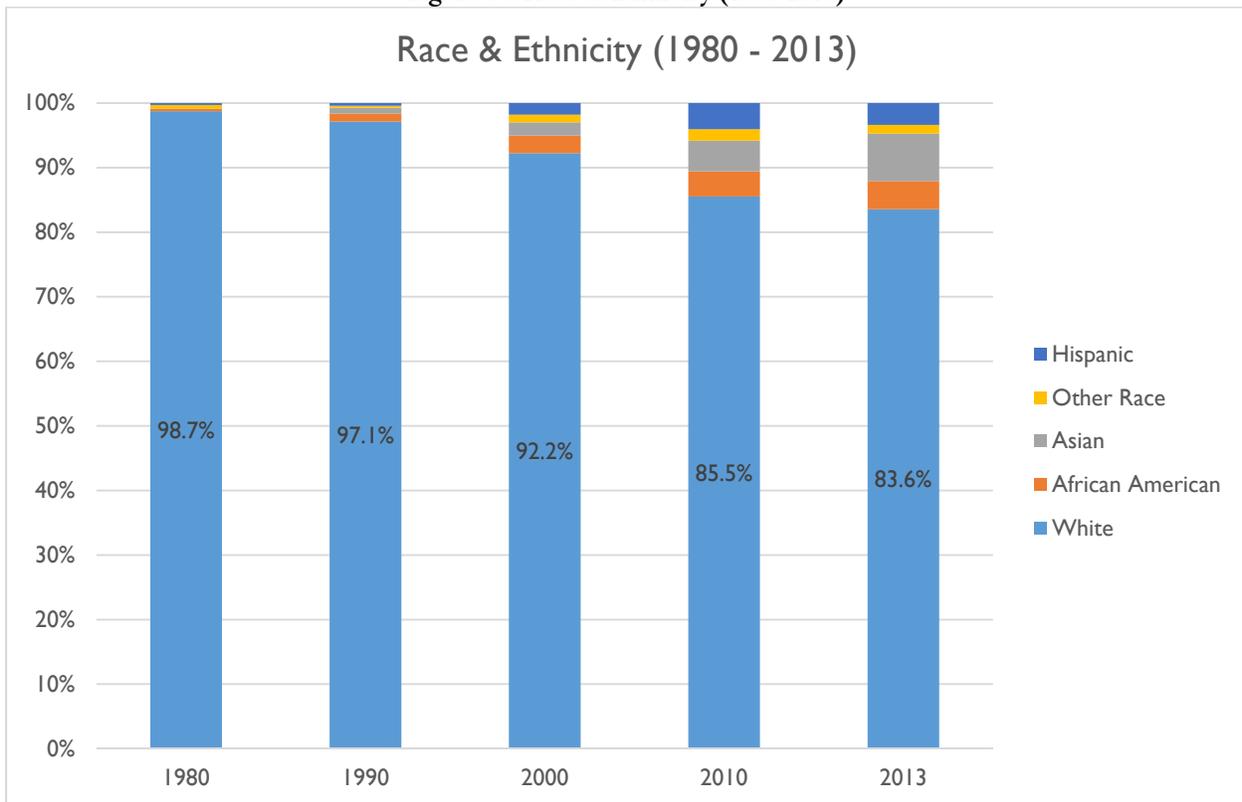

## Age

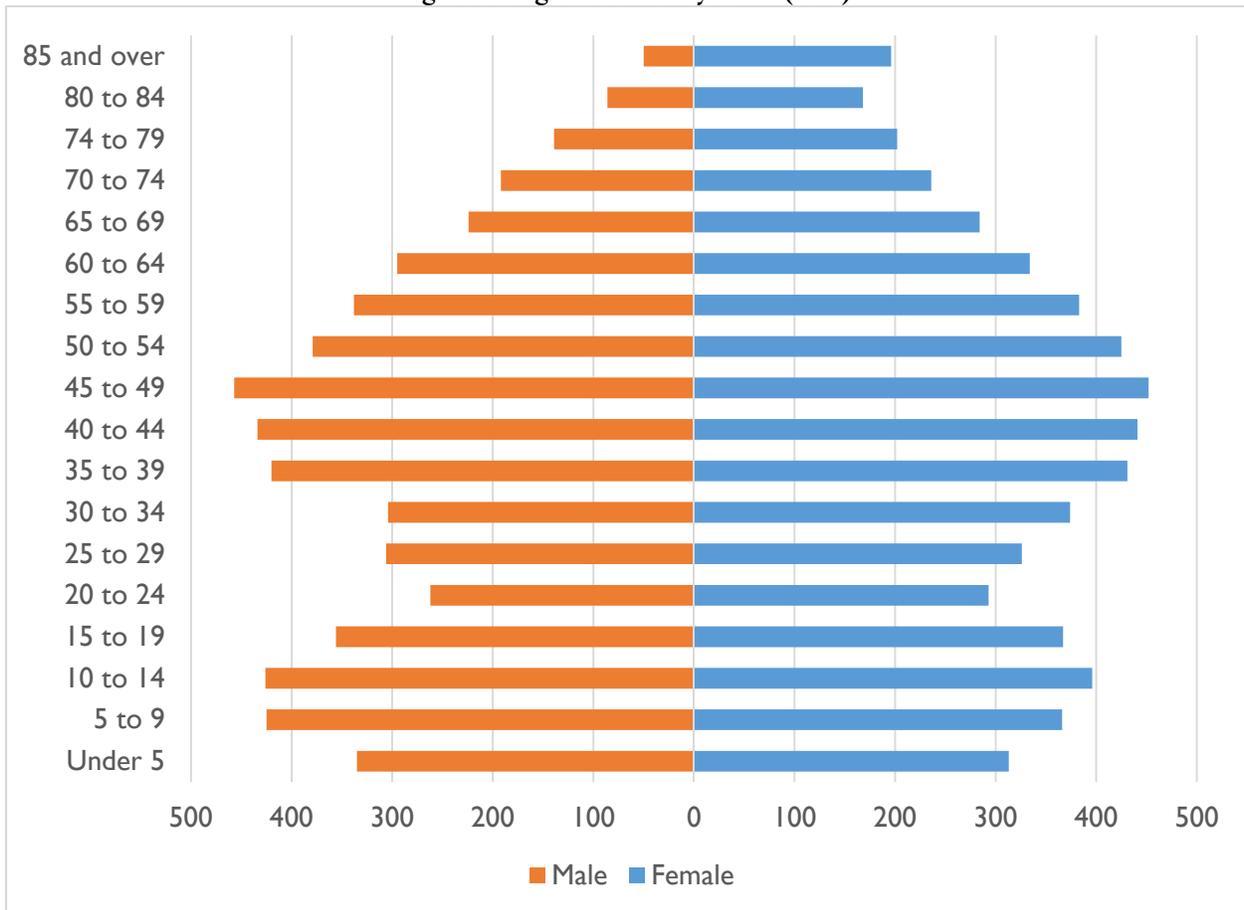

## Households

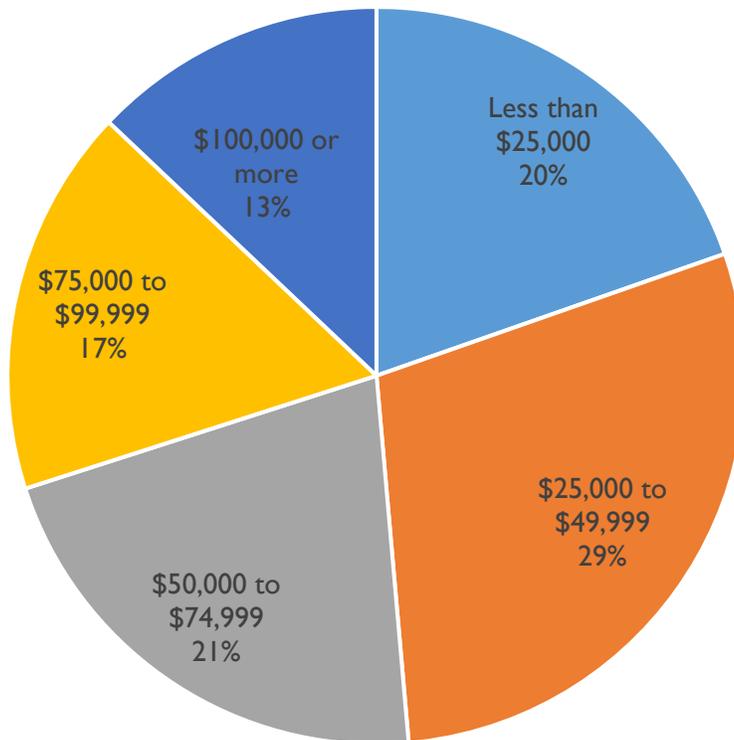

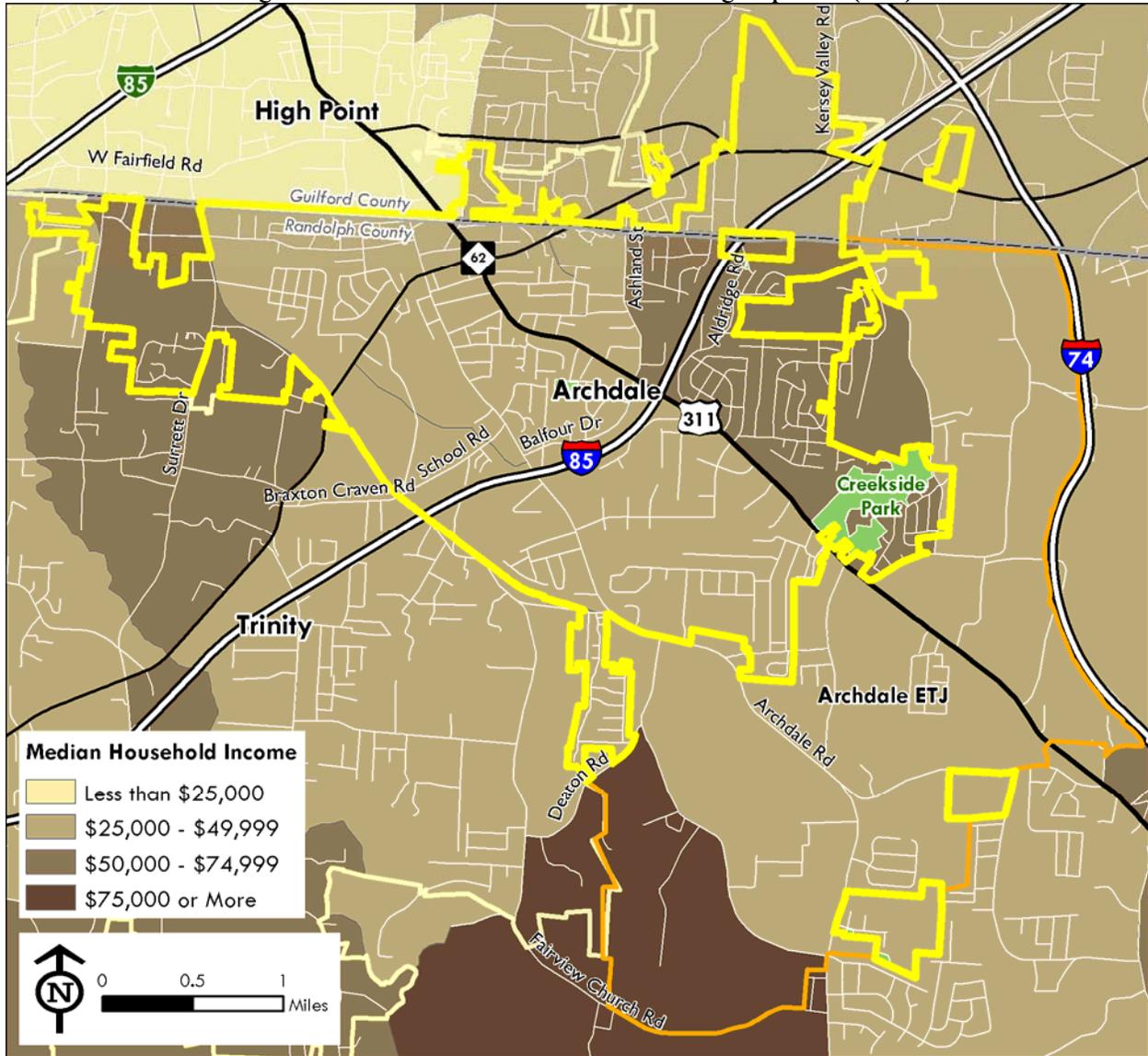

## Educational Attainment

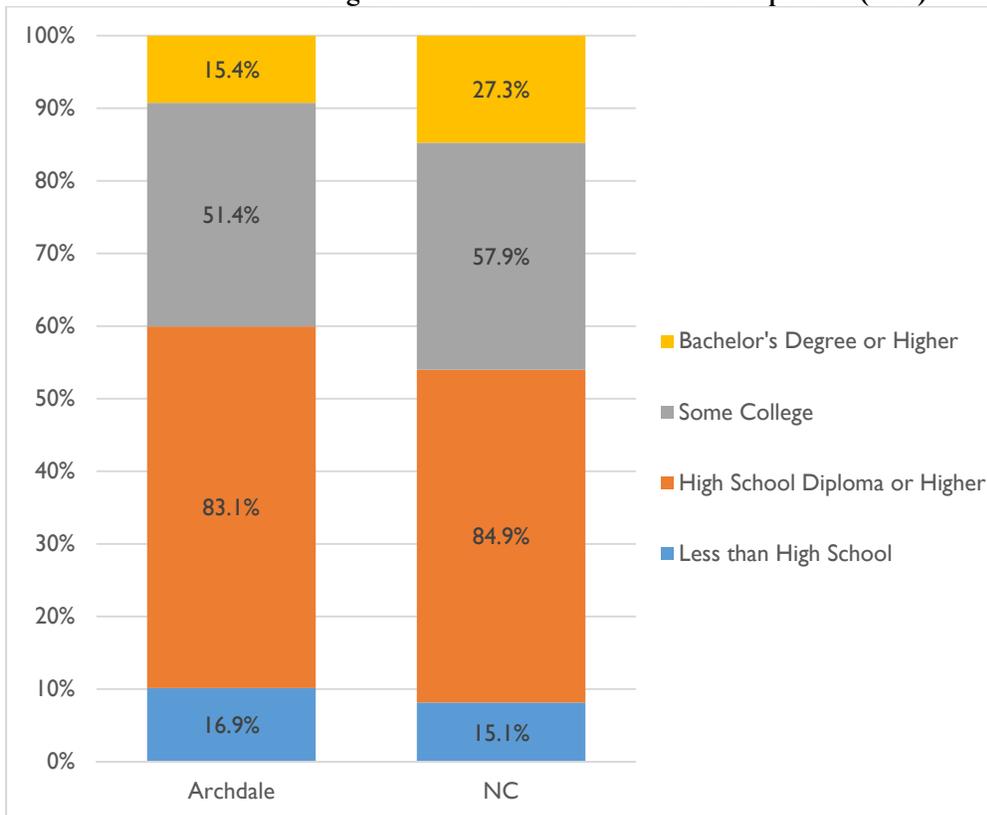

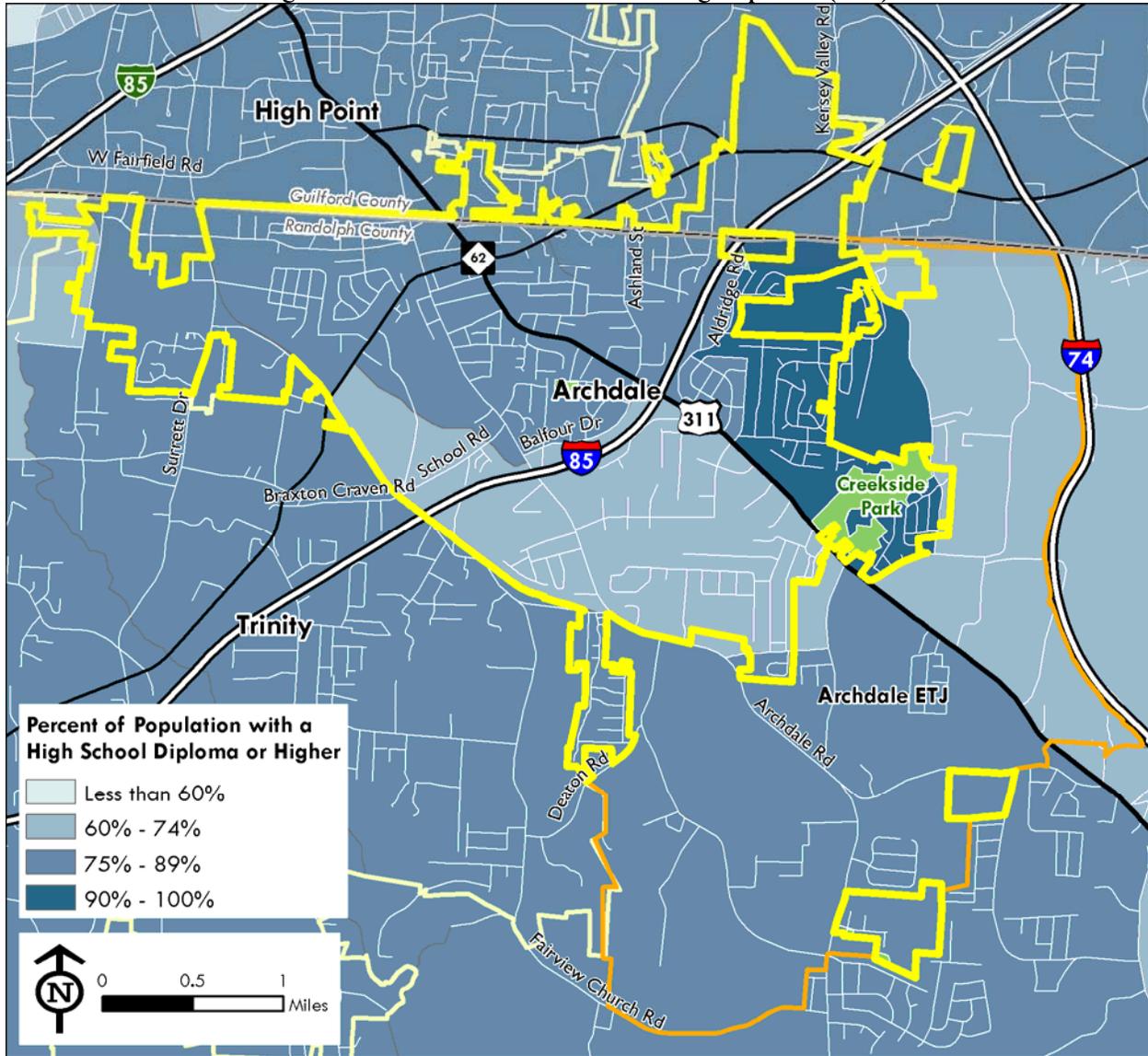

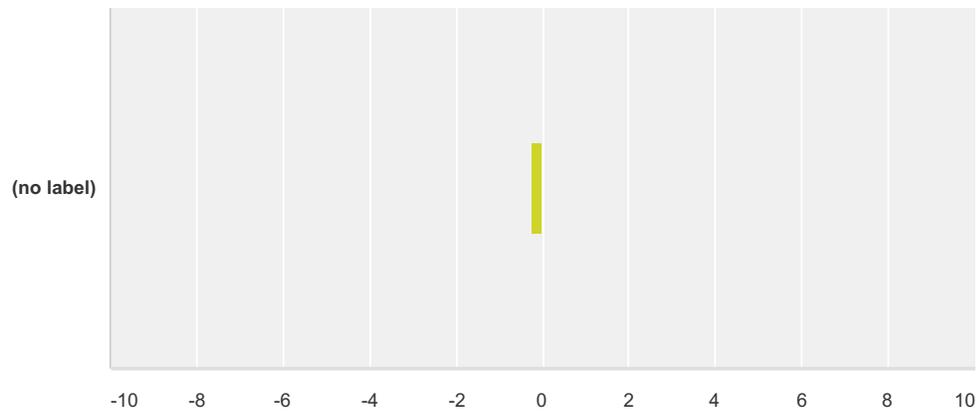

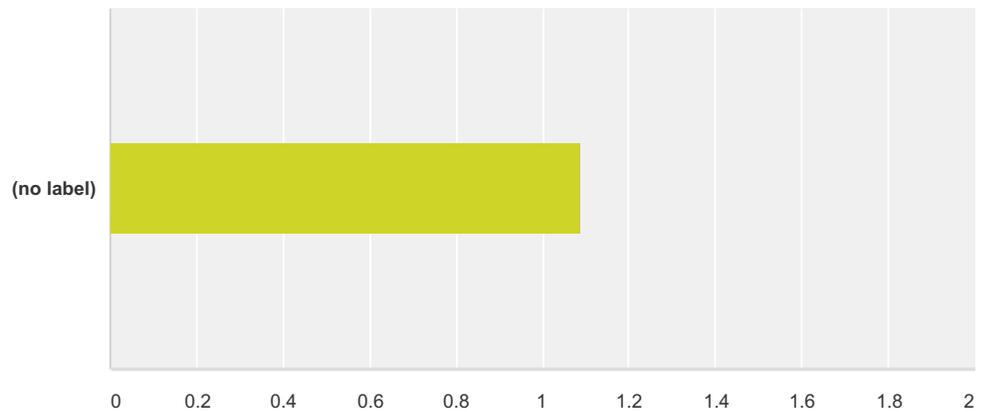

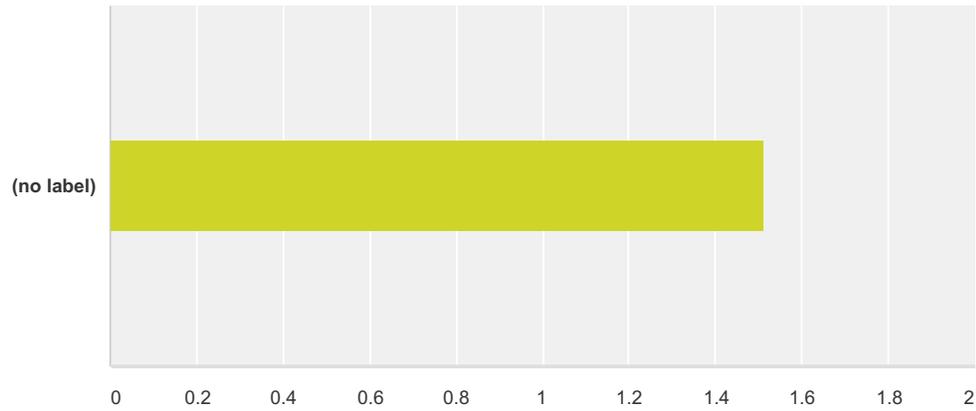

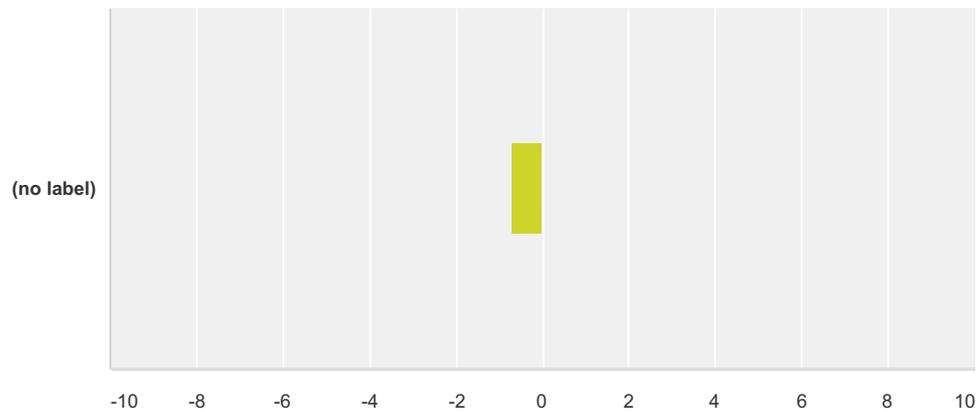

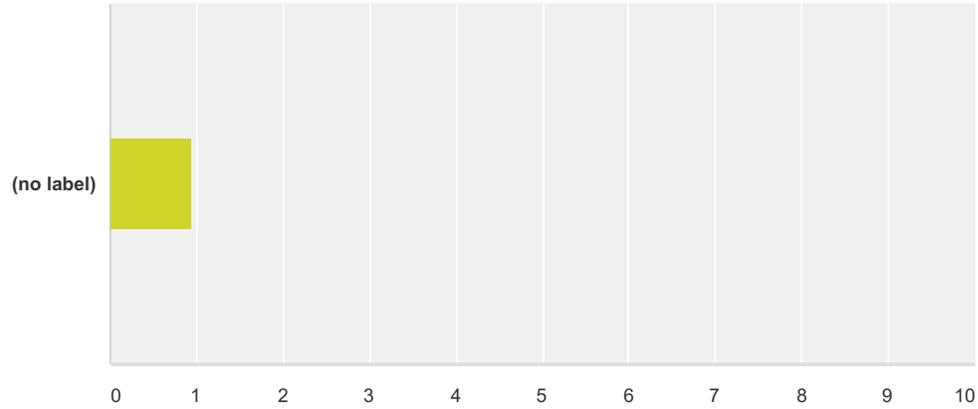
